The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of March.

Incident reports:

Case # 14-1802, 03/01/2014, at 2208 hrs - 6500 W. Greenfield Av. - 6500 Bar

On 03/01/2014 at 2208 hrs., Officers, responded to 6500 W. Greenfield Av, 6500 Bar for a report of a Disorderly subject inside the bar. Officers made contact with Danial Charles Blise, who was attempting to fight other patrons and was heavily intoxicated. Blise was immediately uncooperative with officers and refused to follow commands. Blise was directed to the ground, after attempting to grab the keys that were just removed from his possession by officers. Blise continued to resist by kicking, pulling his arms beneath his body, and attempting to bite and spit on Officers. Blise was transported to AWAMC for facial injuries. He had several final commitments through Greendale and was issued Disorderly Conduct and Resisting Officers Municipal Citations.

Case # 14-1908, 03/04/2014, at 2139 hrs - 6001 W. Madison St. - Kokopelli's Pub & Grub

On 03/04/2014 at approximately 2139 hrs., Officers responded to 6001 W. Madison St, Kokopelli's Pub & Grub for a male refusing to leave. Upon Officers arrival, the male fled and went into the Remedy Bar. Officers made contact with Robert I. Hayes, who was extremely intoxicated and yelling at Officers. Investigation revealed Hayes spit in a customer's face and in her food while yelling at her to shut up. Hayes was screaming profanities inside the bar and making everyone uncomfortable so they asked him to leave. Hayes was arrested for Disorderly Conduct and received a municipal citation.

Case # 14-1939, 03/05/2014, at 2112 hrs - 7534 W. Beloit Rd. - Sir Gregory's Pub

On 03/05/2014, at 2112 hrs., Officers responded to 7534 W. Beloit Rd., Sir Gregory's Pub, for a man saying he needed help. Officers located Russell Kengott inside Sir Gregory's Pub who was intoxicated. A witness said Russell claimed he had not taken his psych medication and needed help. Russell said he wanted to go to MCMH. Russell appeared very agitated, upset and intoxicated to the point he could not care for himself. Russell agreed on scene to go to MCMH, but changed his mind on the ride to the facility. He was taken to MCMH and detained under Chapter 51.

Case # 14-2043, 03/09/2014, at 0148 hrs – 8900 W. Greenfield Av., Larry Michaels Club & Café

On 03/09/2014, at 0148 hrs., Officers responded to 8900 W. Greenfield Av, Larry Michaels Club & Café for a fight outside the tavern. Two male brothers were highly intoxicated, being loud and causing a disturbance. One of the brothers was found to be in possession of a baggie of marijuana. He was arrested for Possession of THC, issued a local citation and released.

Case # 14-2304, 03/18/2014, at 0332 hrs - 7100 W. National Av - Craig's Pub & Eatery

On 03/18/2014, at 0332 hrs., Officers responded to 7100 W. National Av, Craig's Pub & Eatery for a trouble call. Investigation revealed Ryan Bushberger and his brother, Garett Bushberger, were involved in a physical confrontation. As Officers arrived, Garett did not comply with Officers commands and he was later tased. Ryan was arrested for Disorderly Conduct/Domestic Violence. He was also issued a Municipal Citation for Resisting Officers. Ryan and Garett were employees of the tavern. Ryan was reported to be highly intoxicated.

Case # 14-2468, 03/22/2014, at 2357 hrs – 6007 W. Burnham St. W – Las Palmas

On 03/22/2014, at 2357 hrs., Officers responded to 6007 W. Burnham St., Las Palmas for a report of two parties fighting with security. Officers arrived on scene and took into custody Santiago I. Cabrera-Guerrero and Isabel Gonzalez – Iniguez. Security Officers advised they physically fought and were struck several times by both parties. One Officer sustained a bloody lip from the incident. Cabrerea and Iniguez were issued Municipal Citations for Battery.

Case # 14-2469, 03/23/2014, at 0030 hrs – 8824 W. Becher St. – Walleye Saloon

On 03/23/2014, at 0030 hrs. Officers responded to the Walleye Bar, 8824 W. Becher St, for the report of Criminal Damage to Property. Upon arrival, contact was made with the caller/bartender, Austin B. McCullough, who stated a known party, Kristin K. Provencher, was leaving the bar and had hit a double pane window with her hand, causing it to break. Investigation revealed Austin used disparaging terms toward Kristin, which caused her to become angry. Kristin was issued a Municipal Citation for Criminal Damage to Property.

Case # 14-2646, 03/29/2014, at 0224 hrs – 9440 W. National Av – Brooklyn's

On 03/29/2014 at 0224 hrs., Officers responded to Brooklyn's Gentlemen's Club, 9440 W. National Av, for a weapons call. William Johnson stated Nicolas Natarelli lunged at him with a folding knife, stabbing him in the left forearm. Parties involved were intoxicated. Nicolas was arrested for 1st Degree Recklessly Endangering Safety.

Case # 14-2714, 03/31/2014, at 0331 hrs - 1576 S. 75 St - Nite Court

On 03/31/2014, at 1845 hrs., Officers were dispatched to 1576 S. 75 St for the report of an intoxicated male making suicidal statements. The Offender, William Adamek stated he was at Nite Court drinking and consumed 22 beers between 0900 hrs and 1800 hrs. William also stated he snorted 2 lines of cocaine at the bar and took a hit of marijuana.

On 02/12/2014, Officers conducted a business check and did not observe any violations. Spadafora, the business owner, stated she is aware of the ordinance and does not allow people to bring alcohol to the classes. She is not seeking a license now because of the cost involved.
