The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of July.

### Incident reports:

#### **Case #15-28435, 07/01/2015, 2041 hrs: 10114 W Greenfield Av – Las Fajitas Restaurant**

On 07/01/2015, Officers found Las Fajitas was selling liquor without a liquor license. The bartender admitted to serving alcohol to patrons. The license expired on 06/30/2015. The bartender was issued a municipal citation. The owner of Las Fajitas was also issued a municipal citation.

#### **Call #15-28657, 07/03/2015, 0211 hrs: 7731 W. Becher St – Quencher's**

On 07/03/2015, Officers responded to Quenchers for multiple parties who were engaged in a physical altercation outside of the tavern. After the initial altercation outside of the tavern, another altercation took place in the 1900 block of S. 77 St. The three male parties engaged in the initial altercation stated they did not want to pursue any charges. Officers later located two offenders running away, failing to stop as the Officers commanded. They were both arrested for Disorderly Conduct and Hindering an Officer. The incident began over patrons standing in front of Quenchers and intoxicated citizens walking by, wanting them to move.

#### **Case #15-29176, 07/05/2015, 2345 hrs: 6540 W. Grant St – Alibi Bar**

On 07/05/2015, Officers responded to the residence of 2166 S. 64 St for a report of a 911 hang up call. Investigation revealed that a party was at the Alibi Tavern when a male made a comment about her and his dislike for Mexicans. The party's boyfriend and friend confronted the male and both were assaulted as a result. The identity of the Offender is not known.

**Call #15-30232, 07/12/2015, 0254 hrs: 7534 W. Beloit Rd – Sir Gregory's Pub**

On 07/12/2015, Officers responded to the area of 7500 W. Beloit Rd for five individuals fighting and one male struck by a vehicle. The investigation revealed a party drove his vehicle towards multiple persons, striking one party, causing him to black out for approximately two minutes. The Offender was arrested for Recklessly Endanger Safety – 2<sup>nd</sup> Degree, OWI Causing Injury, Operating after Revocation and Hit and Run – Injury. The Offender was found at his parent's residence, taken into custody, transported to CJF and subsequently Charged at the District Attorney's Office. The Offender had been thrown out of the tavern by the bartender for his level of intoxication and behavior towards other patrons.

**Case #15-31376, 07/18/2015, 2203 hrs: 9000 W. National Av – Scooters Tap**

On 07/18/2015, Officers responded to Scooter's Tap for a complaint of a physical altercation. Contact was made with two parties who were walking away from the scene. Investigation revealed they came to Scooter's looking for a particular party, wanting to harm him. This party was inside Scooter's, talking with the bartender. One Offender attacked the party without provocation, pushing him into a wall. To protect himself, the other party punched the Offender once in the head, causing a two inch laceration. The attacking Offender was arrested for Disorderly Conduct, while his friend was arrested for Disorderly Conduct and Obstructing.

**Case #15-31543, 07/19/2015, 2310 hrs: 8031 W. Greenfield Av – Paulie's**

On 07/19/2015, Officers responded to Paulie's for a report of a known male party displaying a firearm at the bar. Investigation revealed there was an argument between two parties and one party went to his vehicle, grabbed a firearm, pointed it in the air and racked the slide. The Offender was intoxicated and had been drinking inside the tavern. He was not located and no citations were issued.

**Case #15-31961, 07/21/2015, 1830 hrs: 6540 W. Grant St – Alibi Bar**

On 07/21/2015, Officers responded to The Alibi Bar to investigate a report of a theft. The business owner advised an unknown suspect broke into 4 slot machines inside the bar sometime during business hours. The owner stated the bartender was found highly intoxicated, passed out behind the bar at approximately 0930 hrs. He apparently never left the bar due to his high level of intoxication. The bartender stated he was consuming intoxicants while at work and possibly drugged. Video was recovered and the manager was able to identify five suspects from the video footage. Four black males and one white female entered the business. Two individuals appeared to try and distract the bartender while the others broke into the machines. After the machines were entered, they took the cash and left the business without the bartender knowing what happened. They may have tried this same thing at Johnny Hammers, 6300 W. Lincoln Av. Call #15-31857

**Case #15-32533, 07/26/2015, 0226 hrs: 9646 W. Greenfield Av – Dickens Grille**

On 07/22/2015, Officers responded to Dickens Grille for a report of a subject falling on the sidewalk. The party fell due to high intoxication and stuck his head on the side of a building, causing him to become disoriented and suffered a cut to his head. He was transported to Froedtert Hospital. The party became so intoxicated inside the tavern, he began vomiting within the bar and was escorted out by staff. The bartender stated he did not seem to be unreasonably intoxicated when he came in and was served one drink.

**Case #15-32595, 07/26/2015, 1439 hrs: 11505 W. National Av – Natty Oaks**

On 07/26/2015, Officers responded to Natty Oaks for a report of a son who threw coffee and beer at his mother and tried to fight reveal other customers. Investigation revealed they were at the tavern eating a meal together, when they got into a verbal argument, which turned physical. The male Offender ran out of the business, but was later located by Police. He was arrested for Disorderly Conduct/Domestic Violence.

On 07/09/2015, Officers conducted ten tavern checks at randomly selected West Allis businesses that have a license to serve alcohol beverages. The check was completed through the use of a 19 year old male who entered each tavern and attempted to purchase a beer without providing identification. Out of the ten businesses, three asked for identification and would not provide the beverage without it. Employees from the seven taverns that did not require identification were issued citations through the mail. The owners from the seven businesses were issued citations as well.

**Case #15-33216, 07/30/2015, 1005 hrs: 6300 W. Lincoln Av - Jonny Hammers**

On 07/30/2015, an Officer conducted a tavern check at Jonny Hammers. Contact was made with the bartender, who claimed she didn't have her bartending license with her. The Officer learned her license had expired. She did not have a licensed bartender on scene supervising her during her shift. She was cited for Operating a Licensed Premise without a Licensed Person. The agent, was also cited.
