The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the months of December 2016. Two (2) additional incidents from November and December 2016 involving The Shooter's Shop are included.

**Incident reports:**

**Case #16-048327 // 24 November 2016 at 0031hrs. // Heartbreakers – 9442 W. National Ave. // NO VIOLATION**

**Caller was manager – Steven Pohlabe**

On 11/24/16 at approximately 0031 hrs. officers were dispatched to 9442 W. National Ave. for a report of a male party causing damaging to the building. Officers spoke with Heartbreakers manager, Steven N. Pohlabe (m/w 03/29/85), who advised a m/w approximately 25-35 years old, wearing a dark colored shirt, damaged the wires for the accent lights outside the bar. The male then entered a white Dodge Ram with unknown plates and left the area. Investigation is on-going.

**Case #16-048427 // 25 November 2016 at 0243hrs. // One More – 7534 W. Beloit Rd. // NO VIOLATION**

**Caller was victim of incident.**

On 11/25/16, at approx. 0243hrs, Officers responded to 7534 W. Beloit Rd. for a vehicle that had its windows smashed out by a brick. Upon arrival, contact was made with the victim, who stated her ex-boyfriend, whom she stayed with on and off for a year, had thrown a brick through the front passenger side window and also at the front windshield on her vehicle, WI-Reg: 802-VDL, which was parked on the street. Prior to damaging the vehicle, he entered the bar and a

confrontation ensued which lead to him punching her in the right ear causing a small amount of blood.

**Case #16-048683 // 26 November 2016 at 2209hrs. // 6321 W. Mitchell St. FKA: Junebug's Underage party held at previously licensed premise now owned by Alfredo Nungaray.**

**Caller was a citizen. Called regarding the loud noise / music.**

On 11/26/16 at approximately 2209 hours, officers were dispatched to 6321 W Mitchell St for a report of loud music coming from the old Junebug's Bar. Investigation revealed numerous underage parties were consuming alcohol. All necessary parties signed PR bonds on scene and sent on their way.

**Case #16-048712 // 27 November 2016 at 0226hrs. // Remedy – 1309 S. 60 St.  
NO VIOLATION**

**Caller was employee / bartender: Megan Brown**

On 11/27/16 at 0226hrs., officers responded to Remedy Bar, 1309 S. 60th St., for a physical fight. Several individuals were involved in a fight and the instigators fled the scene prior to officer arrival.

**Case #16-050122 // 07 December 2016 at 1717hrs. // Slurp n Burp – 1454 S. 92 St.  
NO VIOLATION**

**Caller was co-owner: Kimberly Mathy**

On 12/07/16 at approx. 1717hrs., officers responded to Slurp N Burp, 1454 S 92 St., regarding a physical fight. Investigation revealed an intoxicated patron began yelling at the bartender and a patron prior to throwing a potted plant and napkin holder at a customer. The female individual was arrested for Disorderly Conduct and Criminal Damage to Property.

**Case #16-050130 // 07 December 2016 at 1851hrs. // Fiddler's – 6108 W. Burnham St.  
NO VIOLATION**

**Caller was employee: Kathleen Glowing**

On 12/7/16 at 1851hrs I responded to 6116 W. Orchard St. for an armed robbery that occurred at Fiddler's Bar, 6108 W. Burnham St. I spoke with the victim, who said she had just opened the bar and was standing at the cash register with her back to the door. A black male, about 5'8", average build, wearing a black mask and Army style green coat, came in and pointed a black hand gun (silver muzzle) at her. The man ordered her to open the cash register and get on the ground. The man emptied the register of cash and also demanded the blue money bag. The man took the bag along with victim's Samsung Galaxy S7 and the bar's cordless V-tech phone. The man left in an unknown direction with approximately \$870 in cash and coin.

**Case #16-050209 // 08 December 2016 at 0030hrs. // Boosters West – 7731 W. Becher St.  
NO VIOLATION**

**Called was the victim of the theft.**

On 12/08/2016 at 0030hrs, I took a report of a theft that took place on 12/06/2016 at 2230hrs, at Boosters West, 7731 W Becher St. I made contact with the victim, who stated an unknown party stole her purse which was sitting on a table. Surveillance video shows a male white suspect enter the bar and conceal two purses in his jacket. The male is only inside the bar for approximately 4 minutes. Through the use of social media a suspect has been identified.

**Case #16-050551 // 04 December 2016 at approximately 0230hrs. // Remedy – 1309 S. 60 St.  
BARTENDER VIOLATION**

**Complainant was tavern owner – Erwin C. Magritz**

On 12/05/16 officers responded to Remedy Sports Bar for a disorderly conduct investigation. During follow investigation, the bar owner Erwin C. Magritz, M/W 09/03/51, advised he was reviewing the bar's surveillance footage from the previous night. The bar tender for that night, Megan S. Brown, F/W 11/04/86, allowed patrons to stay in the bar and consume alcohol past 0330hrs. Video surveillance was obtained and Magritz statement was confirmed. Brown was later mailed a citation.

**Case #16-050564 // 11 December 2016 at 0147hrs. // 6500 Bar – 6500 W. Greenfield Ave.  
NO VIOLATION – although one unlicensed person tending bar and one with a city of Milwaukee license**

**Unknown caller / complainant**

On 12/11/16 at 0147hrs officers responded to 6500 Bar, 6500 W Greenfield Ave for a report of numerous people fighting inside. Officers arrived on scene and observed approximately 30 people dispersing from the bar as well as shouting and yelling in the street. Officers spoke with numerous parties who all refused to cooperate or provide statements. Bar information was collected and will be forwarded to the licensing committee.

**Case #16-050879 // 13 December 2016 at 2359hrs. // Spotite – 6426 W. Greenfield Ave.  
BARTENDER VIOLATION**

**Caller / complainant was from inside establishment – unknown who**

On 12/13/16 at 2359hrs, officers responded to Spot Lite at 6426 W. Greenfield Ave. for a report of a physical fight. Upon officers arrival the offenders fled the business in an unknown location. Investigation revealed the victim, was highly intoxicated inside the business and accusing employees of stealing his wallet. The two offender's attempted to calm him down, but when he did not calm down, the two assaulted him. During the investigation an employee, Emiliana P.

Lorenzo, F/W 06/02/91, gave officers a false name and D.O.B. Upon obtaining her real information, she was arrested for Obstructing and a Felony warrant through Milwaukee County Sheriff's Office.

**Case #16-051916 // 21 December 2016 at 1815hrs. // Scooter's Tap – 9000 W. National Ave.  
NO VIOLATION**

**Caller / complainant was from inside establishment – unknown who**

On 12/21/16 at approximately 1815hrs., officers responded to Scooters Tap, 9000 W National Ave., regarding a physical fight. A female offender took a purse off the table from a patron and attempted to run out of the business. Two (2) individuals restrained the offender while police arrived. While they held the offender, she brandished a knife and continued to hold on to the purse. The knife was eventually removed from her possession. During search incident to arrest officers discovered multiple needles and pills which she didn't have a prescription for. The offender was arrested for Armed Robbery w/ use of force, possession of drug paraphernalia, possession of a controlled substance, and bail jumping. She was subsequently transported to CJF.

**Case #16-052116 // 23 December 2016 at 0955hrs. // Kip's Inn – 837 S. 108 St.  
NO VIOLATION**

**Caller was employee – Jane Lundy**

On 12/23/16 at 0955 hrs, Officers responded to Kip's Inn, 837 S 108 St, for a report of two disorderly customers in the business. The parties left in a vehicle prior to Officers initial arrival, but returned a short time later where one offender admitted to driving. Investigation revealed the two offenders were intoxicated and trying to instigate fights with other customers in the bar before leaving. They also threw items around the bar and poured beer on the cash register causing damage. Both were arrested for Disorderly Conduct. One was also arrested for Criminal Damage to Property and OWI (1st). Both were transported to the station, booked, cited and eventually released.

**Two (2) recent incidents involving The Shooters Shop – 2465 S. 84 St.**

**Case #16-048758 // 27 November 2016 at 1536hrs.**

**Initial call to police was received at approximately 1519hrs. by unknown individual**

**Second call from The Shooters Shop to police was received at approximately 1553hrs.**

On 11/27/16 at approximately 1536hrs., officers were dispatched to AWAMC regarding a male party leaving the parking lot after placing items into a case and leaving it in the bushes. Investigation revealed a male individual left the shooter shop and took a MK4 Semiautomatic rifle and was later seen walking westbound on W. Arthur St., from S 88 St. While on scene AWAMC security reported someone heard a gunshot coming from the east parking structure. Officers conducted a protective sweep of the area and the east parking structure and discovered the male in the southeast stairwell on the fifth floor unresponsive with a gunshot wound to the head. The Medical Examiners Office arrived and pronounced him deceased at 1821hrs. The body was subsequently transported to the ME's Office.

**Case #16-049836 // 05 December 2016 at 1527hrs.**

**Caller was an emergency room doctor. West Allis Police never received a call from anyone at The Shooters Shop.**

On 12/05/16, officers responded to Aurora West Allis Medical Center for a report of a gunshot wound. Contact was made with a male individual, who indicated he was at Shooter Shop, 2465 S 84 St, when he accidentally discharged his Rock Island 1911 .45 caliber pistol. The bullet struck his left foot. The male informed employees at Shooter Shop of the incident and then drove himself to the hospital for treatment.

**Tobacco and Alcohol Compliance checks:**

A tobacco compliance check was completed on 30 December 2016. Thirteen (13) randomly selected businesses in West Allis were checked. All thirteen (13) businesses were in compliance and there were no violations. For businesses checked, please refer to W.A.P.D. Case #16-052879.

There were no alcohol compliance checks completed in December 2016.
