

Officer Kielley reports...Trouble Call...The Spotlight...6426 W Greenfield Ave....

On 11/06/14 at 1721 hrs. Officers responded to The Spotlight for an assault that had taken place inside the business.

Witness statement...Angela L. Smith, F/W, 11/12/79...

Contact was made with Spotlight employee, Angela L. Smith who stated that during her shift today, her cell phone had gone missing. Smith and her fellow employees were looking for her phone, but were not able to locate it. Smith stated attempts to call the phone to locate it were unsuccessful.

Smith stated at the end of her shift she had gone into the dressing room to get changed. Smith stated that Almestica came into the dressing room and starting throwing things around. Smith did not believe anything was damaged from this. Smith stated that she suddenly looked over and observed her friend, Gayle A. Martin and Almestica fighting. Smith said that Almestica was pulling Martin's hair and striking her. Fearing for Martin's safety, Smith jumped on Almestica's referred to as "Jodi" (later identified as Melissa L. Cummings) had come in and broke up the fight. Cummings then advised Almestica to leave the business. Smith saked Cummings to first check Almestica's purse for her phone. Smith said her stolen phone was located in Almestica's purse and returned to her.

Smith also stated when she had asked Almestica earlier "Have you seen my shitty phone?" Almestica responded by pulling out a can of Mace and pointing at her saying "Have you seen my shitty can of Mace?"

Smith stated that she was not injured during this and none of her property was damaged. She stated that Almestica was out of line and needed to be arrested for her conduct.

Due to Almestica attacking Martin and instigating problems at the business, she was arrested for D.C. I placed her in handcuffs and put her in my marked squad car for transport. Once inside my squad, Almestica started to violently kick the door. As I was transporting her back to the station, she continued to tell me to "hurry up" and that I was " a weak ass ho." Almestica stated all her money "better be" in her bag them slammed her head into the plastic partition in the squad car. When we arrived at the station, I noticed a large bump on the side of Almestica's head from her intentionally slamming her head into the back seat partition. She initially claimed her injury was from the other girls hitting her then stated it was from me "beating" her. I advised her it was from her intentionally striking her own head in the back of the squad car and that her actions were captured on camera. Almestica did not mention her injury again after that.

INITIAL CALL FOR SERVICE

On 11/06/14 at 1722hrs, officers were dispatched to the Spotlight (6426 W. Greenfield Ave.) for a report of a female being assaulted.

CONTACT WITH GAYLE A. MARTIN

On arrival, I made contact with an employee, Gayle A. Martin (f/w, 02/28/78). I asked Martin to tell me what happened, and she stated she finished dancing and made her way to the dressing room. Upon entering the dressing room, Martin observed a multitude of her personal belongings were strewn about on the floor. A few moments later, three female employees, later identified as Kristina C. Almestica (f/h, 07/22/86), Brianna D. Ross (f/w, 01/18/86), and Melissa L. Cummings (f/w, 11/07/81), entered the room.

Martin asked the three women, "Who threw all of my shit on the floor?" According to Martin, Almestica immediately exclaimed, "I'm sick of you bitches accusing me of everything." Almestica then ran at Martin and began punching mer dingthe head and pulling her hair. Martin was not suffer how many times of the

INITIAL INFORMATION:

On 11/06/2014 at approx. 1720hrs, officers responded to The Spotlite located at 6426 W Greenfield Ave to investigate a trouble call. Upon arrival, I assisted officers already on scene by speaking with two parties that observed this incident as it occurred.

STATEMENT - MELISSA L CUMMINGS (WITNESS):

Melissa L Cummings F/W 11/07/1981 advised she is employed at The Spotlite located at 6426 W Greenfield Ave and was working in that capacity when this incident allegedly occurred. Melissa stated she was working behind the bar when she was made aware that another female identified as Kristina C Almestica F/W 07/22/1986 was causing problems inside the business. Melissa stated Kristina was possibly intoxicated or on some sort of drugs and customers inside the bar were making comments about her instability on her feet as

she "performed".

Melissa stated Brianna D Ross F/B 01/18/1986 told her that Kristina broke her phone charger. Melissa stated both Brianna and Kristina went back into the dressing room and were verbally arguing about the broken phone charger.

Melissa stated when she entered the dressing room, she observed multiple parties invovled in a physical altercation. She attempted to break up the fight as there was a lot of hair pulling and slapping between parties. Melissa advised based on what she observed, Kristina's behavior was out of line and she needed to be removed from the bar. Furthermore, Melissa advised Kristina was the primary aggressor and responsible for the altercation between parties.

STATEMENT - BRIANNA D ROSS (VICTIM):

Brianna advised she is employed at The Spotlite located at 6426 W Greenfield Ave and was working when this incident allegedly occurred. Brianna reported Kristina asked to use her phone charger. Brianna provided the phone charger which was functioning before it was given to Kristina to use. Brianna stated when she was given the phone charger back a short time later, it was broken.

Brianna stated she asked Kristina for \$10.00 to cover the cost of the phone charger as she believed Kristina broke it. Brianna reported during her contact with Kristina, she became physically violent and began striking her while in the dressing room. Brianna stated Kristina also broke some of her property while in the dressing room.

While speaking with Brianna she was extremely upset and would not go into detail about her broken property. While on scene, I observed the dressing room which appeared in disarray however I did not directly observe any clearly broken items other than the phone charger originally reported.

Statement of Kristina C. Almestica - Offender

On arrival, I spoke with Kristina C. Almestica F/W 07/22/86, who stated she was assaulted by multiple people inside the bar. Kristina advised she went to the bathroom and when she came out she was confronted by "Jayla" (a stage name) and the bartender, who punched her and pulled her hair. She was unable to provide any other names for the parties who assaulted her. She said the parties assaulted her because they were jealous of how attractive she is and because she makes them look bad. I asked her if there was any kind of conversation or argument before she went to the bathroom and she said there was not. When I asked her again for the names of the people who assaulted her, she said it was a total of three people and could not provide the names.
