The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of September.

**Incident reports:**

**Case #15-37236, 08/20/2015, 0021hrs: 7527 W Becher St–Flappers Tavern (Late reporting)**

On 08/20/2015, Officers responded to Flappers Tavern for a fight in front of the tavern. Investigation revealed one party struck another party in the face. There were also two other parties involved, one remains unidentified. The three were issued municipal citations for Battery and Disorderly Conduct. The bartender called the police and gave a detailed statement.

**Case #15-39705, 09/04/2015, 1801 hrs: 7726 W. Becher St – Booster’s Bar**

On 09/04/2015, Officers responded to Booster’s Bar for an assault; one party attacked another party in the bar. The assault was unprovoked. Due to the altercation, the bartender kicked the offender out of the bar. The Offender was arrested for Disorderly Conduct. Both parties were highly intoxicated.

**Case #15-39911, 09/05/2015, 2220 hrs: 6711 W. Beloit Rd – Rosco’s Sports Bar**

On 09/05/2015, Officers responded to Rosco’s Sports Bar for a physical altercation between a mother and daughter. The bartender had cut the daughter off and she began arguing. The mother told the daughter to leave. The daughter then physically attacked the mother. The daughter was not located and booked, out of custody, for Domestic Violence Battery. The Assistant District Attorney “No Processed” the case.

**Case #15-39941, 09/06/2015, 0040 hrs: 7211 W. Greenfield Av – Seven West Bistro**

On 09/06/2015, Officers responded to Seven West Bistro for two females physically fighting in a parking lot. The altercation began inside the bar when one party was upset that the other party was talking with another female. The primary aggressor was arrested for Domestic Violence Disorderly Conduct. She was unable to post bail and transported to CJF. The other party was arrested on a body only warrant and transported to CJF. The Assistant District Attorney “No Processed” the case.

**Case #15-41342, 09/13/2015, 2059 hrs: 7335 W. Greenfield Av – Mis Suenos**

On 09/13/2015, Officers responded to Mis Suenos for an employee who became physical with two co-workers inside the business. The employee became upset with his niece (employee), held her by her throat against the wall and struck her on the right side of her head. The girl’s ex-boyfriend, pulled him off of her and a fight ensued between the two males. The Offender was arrested for Disorderly Conduct, issued a citation and released.

**Case #15-42123, 09/17/2015, 2203 hrs: 6201 W. Mitchell St – HD Hideout**

On 09/17/2015, Officers responded to HD Hideout for a trouble call. A female party reported she got into an argument with another party at the Hideout, due to allegations he slept with her friend and stole her money. The argument continued outside, when the male punched the female in the face and took her cell phone when she threatened to call police. The female could not provide an actual name for the male party, as they recently met at the bar. The bar owner called the police. The female party was highly intoxicated. The male party was not located.

**Case #15-44003, 09/29/2015, 0107 hrs: 6500 W. Greenfield Av – 6500 Bar**

On 09/29/2015, Officers responded to 6500 Bar for an armed robbery. Two parties were leaving the bar and upon getting into a vehicle, another party opened the driver’s door, taking the business money bag, purse and a cell phone. The Offender fled in a vehicle. An Officer located the vehicle and took two parties into custody for armed robbery, resisting and attempt to disarm a Police Officer. Inside their vehicle, Officers located 2 firearms and all the victims’ property.

**Tobacco and Alcohol Compliance checks:**

- Case #15-43783

An Officer conducted an alcohol compliance check at 13 randomly selected West Allis businesses that have a license to sell alcohol. The check was completed through the use of an 18 year old male who attempted to purchase a six pack of Miller Lite beer. Out of the 13 businesses, 12 asked for identification and would not complete the sale without it. One business, Becher Liquor and Beer, completed the sale and allowed the 18 year old male to purchase the beer without identification. The employee was issued a municipal citation for Selling an Alcoholic Beverage to an Underage Person. The owner of the business was also issued a citation through the mail.
