I am writing to you as part of our ongoing efforts to keep you apprised of developments affecting Time Warner Cable subscribers.

Time Warner Cable's agreements with programmers and broadcasters to carry their services and stations routinely expire from time to time. We are usually able to obtain renewals or extensions of such agreements, but in order to comply with applicable regulations, we must inform you when an agreement is about to expire. The following agreements are due to expire soon, and we may be required to cease carriage of one or more of these services/stations in the near future.

WTMJ, UNIVISION, TELEFUTURA

In addition, from time to time we make certain changes in the services that we offer in order to better serve our customers.

- We were recently informed that Toon Disney's format changed to Disney XD. This change took effect February 13, 2009. Disney XD is currently available on channel 151 on the Digital lineup.
- WPXE informed Time Warner Cable that they will be adding WPXE HD March 16, 2009. WPXE HD will be available on channel 563.
- Real Estate on Demand currently on Channel 1411 will no longer be available effective March 25, 2009.

Additionally, the Office Change of Service fee increased from \$2.00 to \$2.99 effective Wednesday, April 1, 2009. Effective immediately new Digital Phone customers will be accessed a fee of \$14.95 for activation of either a new number or ported number. This fee will help with recovering cost involved with activating digital phone.
