To whom it concerns,

The morning of January 12th, 2016, my vehicle was struck by a West Allis city plow, while parked on the street I live on. The entire driver’s side side mirror was ripped off of my vehicle, luckily there was no other damage. A police report was filed, after the plow driver called to report the accident (case #16-001436 – City of West Allis PD).

Abra Auto Body in West Allis did an estimate on the damage on Monday, January 18th, 2016 with the total adding up to nearly \$160.00 for replacement parts and labor (a copy of that estimate is included).

The city needs to pay for this repair, as well as reimburse me for time wasted to get it fixed. I’ve already taken time off from work to get the estimate done, I’ll need to do the same to get it repaired. Any other information that you need about the incident can be found in the police report, again 16-001436 (as noted on the copy of the ‘West Allis PD Driver Exchange and Information Sheet that is attached).


