**RESOLUTION RELATIVE TO CONTINUING CITY OF WEST ALLIS MEMBERSHIP  
IN THE CITIES & VILLAGES MUTUAL INSURANCE COMPANY (CVMIC) AND  
LIABILITY INSURANCE FOR THE YEARS 2023 AND 2024.**

**WHEREAS**, the City of West Allis became a member of the Cities & Villages Mutual Insurance Company (CVMIC) in late 1987; and

**WHEREAS**, CMVIC is requesting the City confirm the community's commitment to CVMIC for the 2023-2024 policy years; and

**WHEREAS**, the liability insurance coverage for said timeframe includes general, auto, excess, public officials, and law enforcement liability; and

**WHEREAS**, it is recommended that the City of West Allis agrees to continue its membership in CVMIC for policy years 2023 and 2024 based on the premiums guaranteed by CVMIC for said policy years; and

**WHEREAS**, the Common Council deems it to be in the best interests of the City of West Allis to continue the membership.

**NOW THEREFORE**, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that it continues its membership in the Cities & Villages Mutual Insurance Company and renewal of Liability Insurance for the years 2023 and 2024 based on the premiums guaranteed by CVMIC for said policy years.

BE IT FURTHER RESOLVED that the proper City Officials are hereby authorized and directed to sign any and all documents to effectuate the continued relationship and renewal of the Liability Insurance for 2023 and 2024.
