## SUMMARY

Ptm. Stachula reports: 04/22/10 at 0030hrs, Aggravated Assault at Lenny's Tavern 6309 W. National Ave. Matthew H. Adkins M/W 01/15/85 reported that while playing in a pool tournament at the tavern, he was involved in an argument with another patron (First name of Darnell, M/U, early thirties, 6'01", 195lbs, trimmed beard, wearing a silver necklace). After the argument, Adkins walked away and was blind sided (punched four to five times) by the offender. As a result of the assault Adkins lost two teeth and a third was knocked loose. Based on the suspect information provided, Darnell D. Wilber M/U 04/02/78 is considered as a person of interest. Further investigation will be conducted.

I was dispatched to the Aurora West Allis Medical Center, Emergency Room # 12, for a report of a male who was assaulted at Lenny's Tavern 6309 W. National Ave. Prior to responding to the hospital, I stopped at Lenny's Tavern. The doors were locked and no one answered the door. I then responded to the hospital and made contact with Matthew H. Adkins M/W 01/15/85 and his father Gary R. Adkins M/W 03/04/52.

WITNESS STATEMENT - GARY ADKINS

I made contact with Gary and had him step into the hallway, in order to obtain his statement. Gary said that he was with his son, Matthew, at Lenny's for a pool tournament. He said everything was going good and they were getting along with the other teams. He said that as the night went on one of the other team members was getting pretty drunk. He said that Matthew was up and about to shoot, when this party who went by the name of Darnell (later identified as **Darnell D. Wilber M/U 04/02/78**) started stumbling around in front of the pocket Matthew was shooting at. He said that Matthew asked Darnell to move and made reference to proper pool edacity. Gary said that Darnell seemed to be upset by Matthew making the comment and replied "shoot mother fucker".

Gary said that they started to argue and Darnell was calling Matthew a "sweetie" and a "boy". The two got into each other's face and the bar owner, Leonard E. Malan M/W 01/02/45, got in between them. He said that after Leonard broke up the argument, Matthew started to walk away. He said that all of a sudden, Darnell lunged towards Matthew and punched him in the face. Gary said that Darnell continued to punch Matthew in the face and eventually knocked him into the wall and onto the floor. Gary said that he pulled Darnell off of Matthew. He added that Darnell was in good shape and he was to old to try and do anything else. Gary believed Darnell punched Matthew in the face 3-4 times, with a closed fist.

Gary said that after he pulled Darnell off of Matthew, he left the bar with his friend "Jonathan". He said that he went to help Matthew up and noticed that some of his teeth were knocked out. Gary said that he asked Leonard if he was calling the police and he advised that he was just kicking everyone out of the bar for the night. Gary said that Matthew tried finding his missing teeth, but was unsuccessful. He said that as soon as he left the bar, he drove Matthew to the hospital and had the ER staff call the police.

Gary advised that Matthew was in a heated argument with Darnell, but at no time did Matthew throw a punch. He added that Matthew was drinking tonight, but knew to walk away after Leonard broke up the argument. Gary added that Darnell "sucker punched" Matthew and was completely out of line for attacking Matthew.

Gary described Darnell as a male black/Hispanic mix, late twenties to early thirties, 6'01", 195lbs, and wearing a brown or maroon shirt.

VICTIM STATEMENT - MATTHEW ADKINS

I made contact with Matthew who was still in the hospital bed. Matthew was in visible pain. He was having trouble speaking, but was able to provide a statement. Matthew said that he was at Lenny's tonight with his father and entered a pool tournament. He said that during his play, a party by the name of Darnell was stumbling around in front of the pocket he was shooting at. He said that he asked Darnell to move away from the pocket. He said that Darnell was intoxicated and

was yelling "Just shoot mother fucker!" He said that he tried explaining proper pool edacity to Darnell, but he only became more belligerent. He said that he tried ignoring him, but then Darnell started calling him "boy" and "sweetie pie".

Matthew said that he did get in Darnell's face and started yelling at him. He said that the bar owner, Leonard, got in between them and he backed down. He said that after Leonard broke it up, he turned his back and started walking away from the pool table. Matthew said that next thing he knew was being blind sided by a punch. He said that Darnell reached around him and punched him in the face. Matthew said that the first punch was followed by another 3 or 4 and he eventually fell to the floor. Matthew said that he felt a great deal of pain to his mouth and knew that some of his teeth were knocked out.

Matthew said that he was eventually helped to his feet by his father. He said that Darnell fled the tavern and he started looking for his missing teeth. He advised that he was unable to find his missing teeth and he went with his father to the hospital.

Matthew described Darnell as a black/Hispanic mix, late twenties to early thirties, 6'01", 200lbs, wearing a silver necklace and having a tatoo on his left forearm. He was unable to recall what the tatoo was of. *Per Darnell's criminal history check, it shows he has a tattoo (Indian) on his left forearm.*

Matthew added that Darnell was with another party by the name of "Jonathan". He described him as a shorter Hispanic male, late twenties, shorter and athletic build (suspected to be Jonathan H. Torres M/H 05/13/85).

**OBSERVATIONS OF INJURIES**

Matthew had an abrasion above his right eye, which was slightly swollen. Two of his teeth were completely knocked out/missing and a third was knocked loose. The two teeth that were knocked out were the #9 and # 7 teeth (upper front teeth) and the loose tooth was # 8. Matthew advised that the injuries he sustained caused him a great deal of pain.

**MEDICAL RELEASE FORMS**

Matthew signed and dated two copies of the Authorization and Consent for disclosure and release of patient health care records.

**LACK OF CONSENT**

Matthew said that at no time did he give Darnell permission/consent to punch him in the face, causing him to knock out his teeth or to cause him any pain.

After I obtained Gary and Matthew's statement, I responded to the station for further investigation. I recalled that while putting together our department's patrol gang book, I placed a photo of a "Darnell" who fit the description provided by Gary and Matthew. In 2008-2009, several known 21st St. gang members were hanging out at Lenny's Tavern. I checked the "21" street gang section of the book and located Darnell D. Wilber M/U 04/02/78. On Darnell's photo I had previously wrote that he frequents Lenny's and Mario's Tavern.

**PHOTO ARRAY**

Darnell did not have a current photo with our department and per his criminal history, he did not have an adult arrest since 2006. The photo of Darnell in our database was from 2005. At this time I decided to create a line-up with Darnell's 2005 booking photo, since we had no further suspect/offender information at this time. **WITNESS STATEMENT - LEONARD MALAN**

On 04/23/10 at 2330hrs, I responded to Lenny's Tavern and made contact with the owner/bartender (Leonard E. Malan M/W 01/02/45). I asked Leonard if he recalled the fight inside of his tavern on 04/22/10 at about 0030hrs. Leonard said that he did and that after the fight he kicked everyone out and closed the bar for the night. I asked Leonard why he did not call the police. He said that everyone left, so he figured there was nothing we could do.

I asked Leonard to tell me what he witnessed regarding the fight. He said that two guys were involved in an argument over a pool game. He said that Matthew and some other guy by the name of Darrel or Darnell were involved in the fight. He said that Matthew and Darnell were in each other's face and Matthew bumped his chest into Darnell.

Leonard said that he got in between them to break it up. He said that Darnell then

punched Matthew in the face a couple of times. He added that Matthew fell down and apparently got his teeth knocked out. He said that Darnell left and Matthew was going to the hospital with his father. I asked Leonard if Matthew's father (Gary) asked him to call the police and he said he did not.

I advised Leonard that I knew Darnell has been coming to his tavern for several years and plays in his pool league, with his mother Diana. At this time Leonard admitted that Darnell was in fact his name and that he knew him as a regular customer, along with his mother Diana. Leonard said that when the fight occurred Darnell was with his friend Jonathan, but his other teammates had already left the bar (including his mother).

I asked Leonard if he had any pool league paperwork with Darnell's information. Leonard went behind the bar and handed me a roster form with Darnell's team information. I asked Leonard if the Darnell on the roster form was the same Darnell that was involved in a fight with Matthew tonight. He said that it was.

**EVIDENCE**

At this time I collected the M.A.C.D. Pool Roster Form as evidence. The sponsor was Listed as Lenny's B # 774-8100 at 6309 W. National Ave. The Wednesday "Mixed 4 Player" box was checked. The player information was written as follows:

**ATTEMPT TELEPHONE CONTACT WITH OFFENDER / CONTACT WITH DIANA WILBER**

I called the telephone numbers listed on the Roster Form. I was able to speak to a female who identified herself as Diana L. Wilber F/I 06/28/61. Diana advised that she is Darnell's mother. Diana was hesitant to provide any information, but admitted that she was at Lenny's on 04/23/10 with her son Darnell. She said that they played in a pool tournament that night and she left the bar before Darnell. She said that she has not seen Darnell since that night and did not hear about any fight at the bar, involving Darnell.

I advised Diana that I needed to speak with Darnell regarding a fight that occurred that night. I asked her she had a telephone number for Darnell and she

advised she had no way of contacting him. I gave Diana my information and advised her to have Darnell call me as soon as possible. Upon checking Diana's information through the D.O.T. database, her address was listed as 3059 W. Ruskin Ct. # 1 Milwaukee, WI. 53215.

I also called the listed number for Jonathan Torres. A younger female answered and she advised that Jonathan was her cousin and she was uncooperative. I was unable to make contact with the listed number for Sandra Wilber and Robert Skenandore.

**ATTEMPT CONTACT WITH OFFENDER**

As of 04/27/10 0030hrs, I have not received a phone call from Darnell. I responded to his mother's residence at 3059 W. Ruskin # 1 Milwaukee, WI. 53215. with three Milwaukee Police Officers (District 6). Upon knocking on the door of the apartment, I received no answer. I then called the telephone # 414-672-3246 and Diana answered the telephone. I identified myself to Diana and asked her to answer her door. Diana said "hold on" and then hung up. Diana never answered the door and did not answer the telephone upon call back.

I contacted Milwaukee Police Department Bureau of Identification and asked them if they had a current photo of Darnell. They advised they had a photo of Darnell from 2008, from the Milwaukee County Sheriff's Office. I requested them to make a photo array with the updated photo of Darnell.
