SUMMARY

On 6/2/13 at 0148hrs officers responded to Double Barrel for a report of a trouble call. I arrived on scene and made contact with Andrew M Lomax, M/W 11/25/68, who stated he was standing outside of his tavern when Hsiu Yu Zen, F/A 10/20/49, went across the street with an alcohol drink and threw it at Lomax. Contact was made with Zen at Bulldog 60, admitted to the incident on scene, and was subsequently arrested for Disorderly Conduct. Zen was given local citation M130025331 for Disorderly Conduct and was given a court date of 7/1/13 at 0830hrs. Zen was released from the substation after the booking process and advised to stay away from the Double Barrel.

Officer Foy reports...

DISPATCH TO CALL/ARRIVAL ON SCENE

On 6/2/13 at 0148hrs officers responded to Double Barrel for a report of a trouble call. I arrived on scene and made contact with Andrew Lomax, standing outside of Double Barrel. Lomax immediately showed me his t'shirt, which was observed wet from some liquid being thrown at him.

STATEMENT OF VICTIM - ANDREW LOMAX

Lomax stated he was standing outside of his bar, Double Barrel, when Zen came running across the street with a drink in her hand. Lomax stated Zen threw the entire cup filled for alcohol at him. The drink made contact with Lomax' chest area, causing his shirt to get wet. Lomax stated he does not leave his bar due to problems with Zen. Lomax states the problems stem from prior run ins where no good solution came about. Lomax does not know what he did on tonight's date that would cause Zen to throw the drink at him.

LACK OF CONSENT

Lomax stated that at no time did he give Zen consent to throw the drink at him.

STATEMENT OF OFFENDER - HSIU YU ZEN

I made contact with Zen inside of Bulldog 60. I asked Zen to step outside of the business and speak with me. Once outside the business, Zen began to state how Lomax has been sending people from his bar over to hers to cause problems. Zen pointed to several individuals that would travel across S 60 St to buy alcoholic

Zen stated she does not like them to come to the business, however she still serves them because they are paying customers. Zen stated they did not cause any fights on tonight's date but often cause problems. Zen admits she exited the business with an alcoholic beverage in her hand and walked across the street. Zen threw the entire drink at Lomax because of the argument they were having.

ARREST DECISION

Based upon the statement given by Lomax, the evidence of a wet t'shirt, and the admission to throwing a drink by Zen, Zen was placed into custody for disorderly conduct.

BOOKING

Zen was booked for Disorderly Conduct under WAPD booking #13-002533 and given citation M130025331 and given a local court date of 7/1/13 at 0830hrs.

Zen was booked and released from the substation and provided her copy of the citation.
