**RESOLUTION TO DECLARE USE OF THE PAVILION AND A PORTION OF
LIBERTY HEIGHTS PARK BY THE LIBERTY HEIGHTS PARK NEIGHBORHOOD
ASSOCIATION FOR ICE SKATING ON VARIOUS DATES IN JANUARY THROUGH
MARCH OF 2026 AS A COMMUNITY EVENT**

WHEREAS, the Common Council of the City of West Allis declares the use of the pavilion and a portion of Liberty Heights Park by the Liberty Heights Park Neighborhood Association for ice skating on various dates in January through March of 2026 as a community event and will provide the necessary permits to host the events and other support as necessary; and,

WHEREAS, by being a City sponsored event, the City of West Allis agrees to waive all permit fees for holding such an event.


