Joint Review Board Approval of Tax Incremental District Number Seven City of West Allis, Wisconsin

The Joint Review Board convened to review the proposal of the City of West Allis, Wisconsin, to approve an amendment of Tax Incremental District Number Seven, City of West Allis, at a meeting duly noticed and held in the Development Conference Room 220, West Allis City Hall, 7525 W. Greenfield Avenue, West Allis, Wisconsin 53214, on February 18, 2009, at 9:32 a.m. By roll call vote, on a motion duly made, seconded and carried unanimously, the Joint Review Board for Tax Incremental District Number Seven adopted the following resolutions:

RESOLVED that the Joint Review Board based upon one or more of the following criteria found:

- a. The development expected in the tax increment district would occur without the use of tax increment financing;
- b. The economic benefits of the tax incremental district, as measured by increased employment, business and personal income and property value, are insufficient to compensate for the cost of the improvements;
- c. The benefits of the proposal outweigh the anticipated tax increments to be paid by the owners of property in the overlying taxing districts.
- d. The project costs, as defined in 66.1105(1)(f), are hereby determined to be 100% proportionate and directly benefiting off site improvements to Tax Incremental District Number Seven (Whitnall Summit) by enhancing ingress/egress to the district.

RESOLVED that the City Attorney is authorized to make non-substantive changes, modifications, additions and deletions to and from the various provisions of this Motion.

RESOLVED that City of West Allis Resolution No. R-2009-0031, a Resolution to approve the amendment of Tax Incremental District Number Seven, City of West Allis, Wisconsin, pursuant to Section 66.1105(4)(gm) of the Wisconsin Statutes, adopted February 3, 2009, be and is hereby approved.
