NARRATIVE

Pto Kwasinski reports.....

INITIAL CALL:

On 11/28/2014, at 1723 hrs., Sgt. Cato was flagged down at 6426 W. Greenfield Ave., after Richard Rellin, m/w, 01/08/1962, left the business without paying for \$75.00 worth of lap dances.

CONTACT WITH OFFENDER:

I responded to the area and made contact with Richard Rellin. Rellin told me he paid for the lap dances he received and also spent \$200.00 on alcohol at the bar. Rellin was highly intoxicated, I observed his eyes glassy and blood shot, his speech was slurred, and he had an unsteady gait (all common side effects of consuming alcohol known through my training and experience).

Pto Hamilton made contact with the employees inside the bar who advised Rellin could pay \$75.00 for the lap dances he received or they wanted him arrested. Rellin was given this opportunity and had the cash on him. Rellin told me it was a "civil matter" and he would take the citation instead.

Rellin was arrested for theft and conveyed to the WAPD substation.

WITNESS STATEMENTS//LACK OF CONSENT:

BOOKING PROCEDURE//INTERVIEW:

Rellin was mugged and printed for theft. During the booking procedure, Rellin was highly agitated and questioned why officers had arrested him for theft. I issued Rellin his citation and read his Miranda Rights on a recorder. Rellin told me he did not want to speak with me regarding the incident and wanted to be released. Rellin was released without incident

TAVERN REPORT:

A tavern report was completed regarding this incident and forwarded to Lt. Johnson and Capt. Evenson as well as attached to this report.

STOLEN SERVICES:

The \$75.00 dollars worth of services via a "lap Dance" was logged into Phoenix property under #14-008614.

CASE DISPOSITION:

This case is closed as a citation was issued.

NARRATIVE

Officer Hamilton reports

On 11/28/14 at approx. 1724 hrs, I was dispatched to the Spot Lite, 6426 W Greenfield Ave, for a theft complaint. On arrival, I made contact with the business owner, Lonnie D. Bald M/W 08/15/44.

Statement of Lonnie D. Bald - Victim

Lonnie stated one of his employees, Frances M. Orosco F/W 11/16/91, provided a service of three lap dances, valued at \$25 each, to a customer, later identified as Richard Rellin M/W 01/08/62. Lonnie stated Frances advised him Richard left the business without paying the \$75 for the dances. Richard then returned to the bar approximately two minutes later and Lonnie approached him to ask why he did not pay for the dances.

Lonnie stated Richard told him he already paid for drinks at the bar and was not going to pay for the lap dances. When Lonnie told Richard he needed to pay Frances for her time and services, Richard said "Fuck her." Richard then left

the bar a second time and Lonnie followed him outside, whereupon he flagged down a passing squad.

Lonnie stated he wanted to press charges for theft if Richard continued to refuse to pay for the dances.

Lack of Consent

Lonnie stated neither he nor anyone else at the bar gave Richard permission to leave without paying for the dances.

Statement of Frances Orosco - Victim

Frances stated she approached Richard at the bar and asked if he wanted to go to the private dance area. Frances advised him the dances would cost \$25 per song and Richard agreed. After Richard's first dance, he requested a second, then a third. After the third dance, Frances asked Richard to pay her. Richard stated his money was at the bar and told her he had to go to the bathroom. After Richard emerged from the bathroom, Frances again approached him to request payment, to which Richard said he did not know if that was going to happen. She again asked for the \$75, but Richard refused and left the bar. At that time, Frances approached Lonnie and advised him of the situation.
