Resolution to approve the West Allis Water Utility's September 1, 2009 PWAC Rate Adjustment.

WHEREAS, the West Allis Water Utility's rate file includes a Purchased Water Adjustment Clause that allows the Utility to adjust its rates to reflect an increase or decrease in the purchased water expense incurred by the Utility; and

WHEREAS, the West Allis Water Utility purchases water from Milwaukee Water Works as a wholesale customer for distribution to West Allis Water Utility customers; and

WHEREAS, the Utility's wholesale supplier applied for and received a rate increase from the Public Service Commission effective for service rendered on and after September 1, 2009; and

WHEREAS, the West Allis Water Utility applied for a water rate increase in accordance with the Purchased Water Adjustment Clause to offset a rate increase by the Utility's wholesale supplier, Milwaukee Water Works; and

WHEREAS, the Public Service Commission approved a water rate increase effective September 1, 2009 for the West Allis Water Utility to offset the increase in the Utility's purchased water expense.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that the water rates approved by the Public Service Commission per the attached rate schedule be and are hereby approved, said increase to be effective September 1, 2009.

Billing: Bills for water service are rendered quarterly and become due and payable upon issuance following the period for which service is rendered. A late payment charge of 1 percent per month will be added to bills not paid within 20 days of issuance. This late payment charge will be applied to the total unpaid balance for utility service, including unpaid late payment charges. This late payment charge is applicable to all customers. The utility customer may be given a written notice that the bill is overdue no sooner than 20 days after the bill is issued. Unless payment or satisfactory arrangement for payment is made within the next 10 days, service may be disconnected pursuant to Wis. Admin. Code ch. PSC 185.

<u>Combined Metering</u>: Volumetric meter readings will be combined for billing if the utility <u>for its own convenience</u> places more than one meter on a single water service lateral. Multiple meters placed for the purpose of identifying water not discharged into the sanitary sewer are <u>not</u> considered for utility convenience and shall not be combined for billing. This requirement does not preclude the utility from combining readings where metering configurations support such an approach. Meter readings from individually metered separate service laterals shall <u>not</u> be combined for billing purposes.

Public Fire Protection Service

Under Wis. Stat. § 196.03(3)(b), the municipality has chosen to have the utility bill the retail general service customers for public fire protection service.

This service shall include the use of hydrants for fire protection service only and such quantities of water as may be demanded for the purpose of extinguishing fires within the service area. This service shall also include water used for testing equipment and training personnel. For all other purposes, the metered or other rates set forth, or as may be filed with the Public Service Commission, shall apply.
