WHEREAS, Site Investigation includes the collection of additional soil and groundwater samples and subsequent analysis for VOC's, PAHs and other contaminants; and,

WHEREAS, the Authority has entered into a sole source master contract with Ramboll Environ for providing professional environmental consultant services; and,

WHEREAS, the Authority is directing the Executive Director, or his designee, to enter into a professional environmental consulting services contract with Ramboll Environ within the City of West Allis in an amount not to exceed \$25,000.

NOW, THEREFORE, BE IT RESOLVED by the Community Development Authority of the City of West Allis (the "Authority") as follows:

- 1. That the Executive Director, or his designee, be and is hereby authorized and directed to execute and deliver the aforesaid professional environmental consulting services contract on behalf of the Authority.
- 2. That the sum of \$25,000 be and is hereby appropriated from Tax Incremental District Number Twelve Teledyne Site, EPA funds, applicable Tax Increment Finance Districts, and/or other sources of funding.
- 3. That the City Attorney be and is hereby authorized to make such substantive and non-substantive changes, modifications, additions and deletions to and from the various provisions of the Contract, including any and all attachments, exhibits, addendums and amendments, as may be necessary and proper to correct inconsistencies, eliminate ambiguity and otherwise clarify and supplement said provisions to preserve and maintain the general intent thereof, and to prepare and deliver such other and further documents as may be reasonably necessary to complete the transactions contemplated therein.
