Dear Council Members:

The enclosed claim has been referred to this office in accordance with Section 3.05 (6)(a) of the Revised Municipal Code. This office has examined the facts of the claim and the applicable law. Our Opinion regarding liability is as follows:

It is the recommendation of this office that the following claim be placed on file:

Janet O'Connor- Amount \$1,641.56

This is a claim for vehicle damage to the claimant's legally parked and unoccupied car at 856 South 74th Street, West Allis, WI, when it was struck by an on duty West Allis police officer who was backing up while responding to a call. As a result of the accident, the claimant's driver's side door area was damaged. The claimant obtained two estimates from auto repair facilities and on or about June 30th, 2008, filed a claim against the City in the amount of \$1,641.56 for repair of her vehicle.

The City of West Allis Motor Vehicle Crash Review Board investigated this claim on June 4th, 2008, and determined that the officer was at fault for unsafe backing and failure to have control of his vehicle in general. The City Attorney's Office agreed with the findings and decision made by the Motor Vehicle Crash Review Board. The estimates submitted by the claimant were reasonable and from reputable auto repair facilities.

Based upon the above, the City Attorney's Office paid the claimant the amount stated above and obtained a Property Damage Only Release signed by the claimant. Therefore, it is the recommendation of the City Attorney's Office to place this claim on file.

PROPERTY DAMAGE ONLY RELEASE

KNOW ALL MEN BY THESE PRESENTS that JANET O'CONNOR, for and in consideration of One Thousand Six Hundred Forty-one and 56/100 Dollars (\$1,641.56) the receipt whereof is hereby acknowledged, do hereby forever release, acquit and discharge the City of West Allis, Wisconsin, a municipal corporation, its departments, commissions, officials, agents and employees, his, her, its or their successors and assigns and all others directly or indirectly liable, from any and all claims and demands, actions and causes of action, damages, both known and unknown, including future developments thereof, costs, loss of service and compensation on account of, or in any way growing out of, any and all known and unknown property damage resulting or to result from an accident on or about May 23rd, 2008, when a West Allis police officer, while slowly backing up his squad car, struck Ms. O'Connor's legally parked unoccupied vehicle in front of the property at 856 South 74th Street, West Allis, WI, causing damage to the rear driver's side of Ms. O'Connor's vehicle.

I agree that this settlement is in full compromise of a doubtful and disputed claim both as to the question of liability and damages and that the payment is not to be construed as an admission of liability.

I agree that this is a complete release of property damage only and it is understood and agreed that it doesn't constitute a release for any bodily injury resultant from this accident as there were no bodily injuries as a result of this accident.

I further agree that this release and payment pursuant thereto is not to be construed as a waiver by or an estoppel of any party released to prosecute a claim or action against the undersigned for any damages sustained.


This Release contains the ENTIRE AGREEMENT between the parties hereto, and the terms of this Release are contractual and not a mere recital.

Upon review of the claim made by Janet A. O'Connor, an interoffice submitted by Lt. Bykowski and the motor vehicle crash investigation A08052301, I find that the West Allis Police Department is responsible for the damage that occurred in this motor vehicle crash.

The Motor Vehicle Crash Board met on June 4, 2008 to review this incident and found that Officer Treep was at fault. Officer Treep struck a legally parked mini-van while performing a backing maneuver with a marked West Allis Police squad. Officer Treep was issued a written reprimand from the Crash Review Board for not fully using due care during his squad operations on this date.

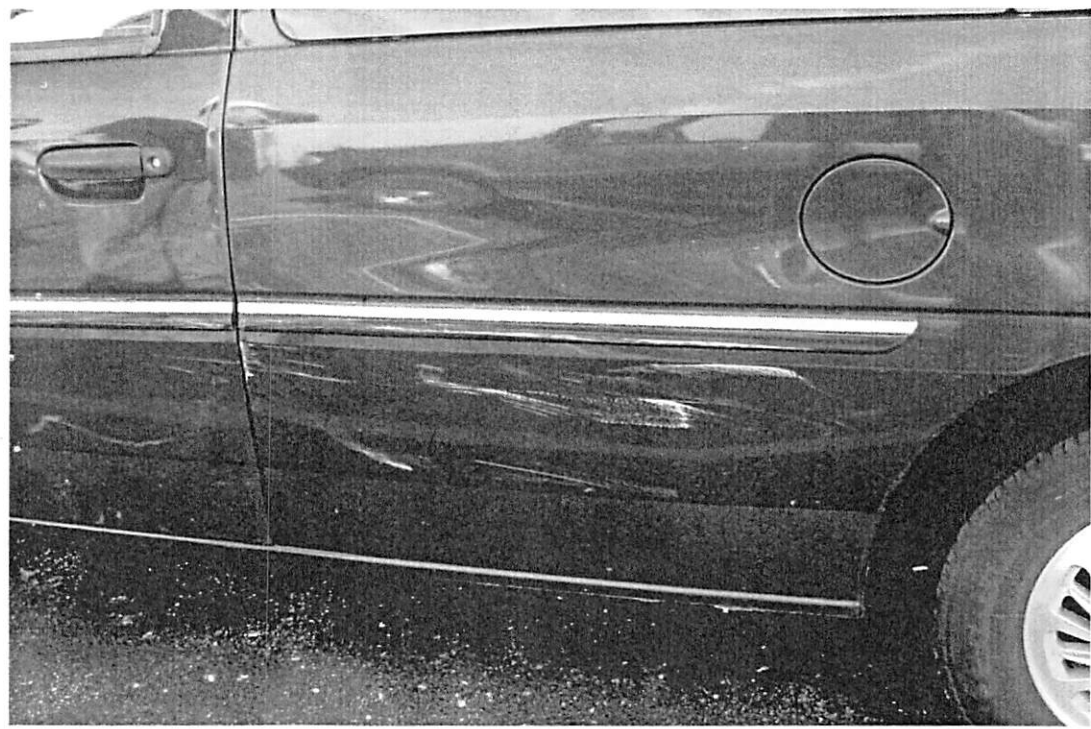
