Dear Mayor Bell:

I am writing as part of our ongoing efforts to keep you apprised of developments involving the ownership of our local cable television system.

I wrote you last fall regarding the AOL Time Warner Inc. agreement with AT&T Corp. to restructure Time Warner Entertainment Company, L.P., ("TWE"), a partnership which holds the cable franchise in your community.

On March 31, 2003, we completed the restructuring of the TWE partnership and approximately 94% of the equity and all general partnership interests in TWE are now or soon will be held by Time Warner Cable Inc. through its wholly owned subsidiary Time Warner NY Cable Inc.

Once again let me assure you that these developments will have absolutely no impact on our cable system, its operations or local management. TWE will continue to be bound by the terms and conditions of the Franchise Agreement, subject to applicable state and federal law.

Please do not hesitate to contact me should you have any questions or if I can be of any assistance. We certainly value the fine relationship we have with you.
