RESOLUTION R-2023-0658**

**RESOLUTION AUTHORIZING THE LIBRARY TO ACCEPT AND EXPEND
FUNDING FROM BLH TECHNOLOGIES, INC.**

WHEREAS, the Medical College of Wisconsin received funding from the National Library of Medicine, National Institutes of Health to support the All of Us Research Program to research patterns to better understand what affects people’s health;

WHEREAS, BLH Technologies Inc. as a contractor for the National Library of Medicine, will provide funding to the West Allis Public Library to expand and improve infrastructure to better serve as a community health hub by actively supporting the enrollment, engagement, and retention goals of the All of Us Research Program;

WHEREAS, the West Allis Public Library was awarded funding to act as a community hub to actively support the enrollment, engagement, and retention goals of the All of Us Research Program;

WHEREAS, the West Allis Public Library serves as the agency responsible for administering these research funds; and,

WHEREAS, effective July 3, 2023, the West Allis Public Library has access to \$99,260.00 in funding to serve as a community health site and actively support the goals of the All of Us Research Program;

WHEREAS, the 2023 budget did not include an appropriation for the improvement and expansion of infrastructure to better serve as a community site for the research program;

NOW THEREFORE, BE IT RESOLVED that the Common Council of the City of West Allis:

1. Authorizes the West Allis Public Library to accept the “All of Us” infrastructure improvement and expansion funds; and
2. Appropriates and amends the 2023 City Budget to allow for the expenditure of “All of Us” infrastructure improvement and expansion funds as allowed in the grant program; and
3. That the Library Director is hereby authorized and directed to take any and all other actions deemed necessary to effectuate the intent of this Resolution.
