

Upon deliberation and consideration of the complaint presented at the License and Health meeting held on September 1, 2009, the Committee finds:

**FINDINGS OF FACT:**

1. That Todd W. Hall and Paul Ray were served a copy of the summons and complaint;
2. That Todd W. Hall and Paul Ray failed to appear to contest the complaint and, thus, the allegations in the complaint are considered to be true;
3. That the conduct of Todd W. Hall and Paul Ray described in the complaint substantially relates to the licensed activity contrary to West Allis Revised Municipal Ordinance 1.08(9) and Wisconsin Statutes §§ 97.30, 254.69 and 254.74;
4. That in particular, Todd W. Hall and Paul Ray's failure to pay their personal property taxes, is contrary to West Allis Revised Municipal Ordinance 1.08(9) and Wisconsin Statutes §§ 97.30, 254.69 and 254.74.

CONCLUSIONS OF LAW:

1. That the foregoing constitutes a sufficient basis to not renew the restaurant license of Todd W. Hall and Paul Ray.

Therefore, the License and Health Committee recommends to the Common Council of the City of West Allis that the Restaurant License of Todd W. Hall and Paul Ray be revoked.
