The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of June.

Incident reports:

Case # 14-4547, 05/28/2014, at 0032 hrs – 1641 S 68 St – Dog House

On 05/28/2014, at 0032 hrs., Officers conducted a walk through at 1641 S. 68 St, Dog House. Contact was made with an underage party who was in possession of his older brother's identification. The bartender advised he only looked at the birthdate and not the picture on the ID. The party was transported, booked, cited and released for Consumption of Alcoholic Beverage, 20 years old. The bartender will be mailed a citation for serving alcohol to the minor. (Late reporting)

Case #14-4907, 06/07/2014 at 0218 hrs., 5732 W Mitchell St – Tap 58

On 06/07/2014, at 0218 hrs., Officers responded to a Trouble Call at Tap 58, 5732 W. Mitchell St. Haytham Asad created a disturbance inside the bar with several patrons, a physical altercation ensued and Asad punched and broke a window to the business. He was arrested for Disorderly Conduct and Criminal Damage to Property. Due to sustained injuries and his intoxicated stated, he was transported to AWAMS for medical treatment. While at the hospital, Asad continued to create a disturbance and later resisted Officers, causing Officers to administer a conducted electrical weapon and use physical force.

On 11/30/2013, at approximately 2244 hrs., Officers responded to 9105 W. Lincoln Av, Draft Tavern, for a Disorderly Conduct complaint. Haytham A. Asad was being disorderly in the bar and was being escorted out by security. He was banned from the bar and advised not to return

per the owner, Paula K. Johnson. Asad left with no problems. There was not a report generated for this incident.)

Case #14-5287, 06/19/2014 at 0201 hrs., 1900 S. 60 St, M&M's Bar

On 06/19/2014 at 0201 hrs., Officers responded to 1900 S. 60 St, M&M's Bar for a report of a male with a bloody nose. The victim advised another male had struck him in the face, breaking his nose. Inside the bar, the bartender, Lori Jones, attempted to lie to Officers and hide the male party in the rear of the business. Jones initially denied any physical fight or knowledge of anyone inside the bar. All three parties were arrested: Jones was cited for Obstructing and remaining on a licensed premise after closing. The Victim and the Offender were cited for Disorderly Conduct.

Case #14-5506, 06/25/2014 at 0214 hrs., 1101 S. 60 St, O'Reilly's Bar

On 06/25/2014 hrs., Officers responded to 1101 S. 60 St, O'Reilly's Bar for two males fighting inside the business. Upon entering the bar, Officers observed copious amounts of blood on the floor, walls and stairs entering the bar. The bartender advised one party lifted a bar stool and threw it at the other man. The bar stool hit the man in the face/upper body area, knocking him to the ground. The parties were located and one party was transported to AWAMS for severe facial injuries. Both parties were issued Disorderly Conduct Citations.

Tobacco and Alcohol Compliance checks:

- On 06/21/2014, an alcohol compliance check at 13 randomly selected West Allis businesses that have a license to sell alcohol was conducted. The check was completed through the use of a 19 year old female who attempted to purchase a six pack of Miller Lite beer. Out of the 13 businesses, 12 asked for identification and would not complete the sale without it. One business, The Corner Spot, 2079 S. 69 St., completed the sale and allowed the 19 year old female to purchase the beer without identification. The employee and the owner of the business were issued Municipal Citations.

Violation of Wisconsin Clean Air Act Smoking Ban:
