An Ordinance to amend Chapter XVII of the City of West Allis Revised Municipal Code to add Section 17.01(17) changing the title of the Department of Building Inspections & Zoning and its Director's title to the Department of Building Inspections & Neighborhood Services.

The Common Council of the City of West Allis do ordain as follows:

PART I. Chapter XVII of the City of West Allis Revised Municipal Code is hereby amended by adding the new subsection (17) in Section 17.01 as follows:

17.01 . . .

(17) Department of Building Inspections & Neighborhood Services.

Whenever the terms "Department of Building Inspections & Zoning" and "Director of Building Inspections & Zoning" are used in this code, it shall be taken to mean "Department of Building Inspections & Neighborhood Services" and "Director of Building Inspections & Neighborhood Services." From time to time hereafter, as pages of this Code are reprinted, the City Clerk/Treasurer shall substitute these new terms for the Department and its Director.

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect January 1, 2009 and be in full force from and after its passage and publication.
