Upon deliberation and consideration of the complaint presented at the License and Health meeting held on March 22, 2016, the Committee finds:

FINDINGS OF FACT:

1. That Vani's Kitchen, Inc., by registered agent, Vigneshwar Bhadharla, was properly served a copy of the summons and complaint, pursuant to Wis. Stat. § 125.12(2)(ar) and West Allis Revised Municipal Code Sections 7.04(16)(c)1 and 9.02(20)(d)1;
2. That Vigneshwar Bhadharla failed to appear to contest the complaint and, thus, the allegations in the complaint are considered to be true;
3. That the conduct of Vigneshwar Bhadharla and Vani's Kitchen, Inc. described in the complaint substantially relates to the licensed activity contrary to Wis. Stat. § 125.12(2)(ag)1 and 4, Wis. Stat. § 125.04(5)(c) and West Allis Revised Municipal Code Sections 7.04(14)(b), 7.04(14)(d), 9.02(6), 9.02(9)(c), 9.02(12)(b), and 9.02(12)(d);
4. That in particular, Vani's Kitchen, Inc.'s failure to obtain all inspections from the Building Inspection and Neighborhood Services Department, provide proof of its Wisconsin Business Tax Registration Certificate, appear at License and Health Committee meetings, and conduct its licensed business at the licensed premises for more than 30 days is contrary to Wis. Stat. § 125.12(2)(ag)1 and 4, Wis. Stat. § 125.04(5)(c) and West Allis

Revised Municipal Code Sections 7.04(14)(b), 7.04(14)(d), 9.02(6), 9.02(9)(c),
9.02(12)(b), and 9.02(12)(d).


CONCLUSION OF LAW:

1. That the foregoing constitutes a sufficient basis to revoke and not renew the Class "B" Fermented Malt Beverage License, Class C Wine License, and Restaurant Permit of Vani's Kitchen, Inc.

RECOMMENDATION:

Therefore, the License and Health Committee recommends to the Common Council of the City of West Allis that the Class "B" Fermented Malt Beverage License, Class C Wine License, and Restaurant Permit of Vani's Kitchen, Inc. be revoked and not renewed.
