RESOLUTION R-2025-5197**

**RESOLUTION TO AUTHORIZE THE PURCHASE OF ONE 2026 FORD F-450 4WD  
CHASSIS AND DUMP BODY WITH SNOWPLOW PACKAGE FOR A TOTAL SUM OF  
\$ 113,442.50**

**WHEREAS**, the Public Works Forestry Division is in need of replacing a 22-year-old dump truck (#213) with snowplow and material spreader, with a new, more efficient, and functional truck which will enhance both the snow and ice control plan as well as Forestry maintenance programs throughout the year; and,

**WHEREAS**, item #41 in the 2025 approved Capital Improvement Program budget includes \$135,000 for the purchase of the above equipment; and,

**WHEREAS**, a proposal has been received from Ewald Automotive Group, the State of Wisconsin contract holder, for delivering one 2026 Ford F-450 60"CA 4WD truck for \$57,600.50, and a cooperative proposal has been received through the National Association of State Procurement Officials from Casper's Truck Equipment for one Henderson Mark III dump body, one Western MVP3 snowplow package, and one Buyers Products SaltDogg material spreader for \$55,842, for a total sum of \$113,442.50; and,

**WHEREAS**, the Fleet Services Division of the Department of Public Works has determined that these proposals meet all desired specifications, and that the proposals received are reasonable; and,

**WHEREAS**, the Common Council deems it to be in the best interests of the City of West Allis that the proposals of Ewald Automotive Group and Casper's Truck Equipment be accepted.

**NOW THEREFORE**, be it resolved by the Mayor and Common Council of the City of West Allis that the proposals dated November 11, 2025 by Ewald Automotive Group for a sum of \$57,600.50 and November 10, 2025 by Casper's Truck Equipment for a sum of \$55,842 for a total sum of \$113,442.50 are accepted.

**BE IT FURTHER RESOLVED** that the purchases will be charged to Account Number 352-4301-533.70-03.

**BE IT FURTHER RESOLVED** that the Finance Department is authorized to enter into a contract for the aforesaid equipment.


