RESOLUTION R-2026-5576**

**RESOLUTION TO AUTHORIZE THE PURCHASE OF ONE NEW LARUE D50
LOADER-MOUNTED SNOW BLOWER FROM MACQUEEN EQUIPMENT FOR A
TOTAL OF \$245,135**

WHEREAS, the Public Works Streets Division must replace a 34-year-old wheel loader-mounted snow blower (#2155) with a more efficient and functional snow blower; and

WHEREAS, item #39 in the 2026 approved budget includes \$255,000 for the purchase of a new snow blower; and

WHEREAS, a cooperative proposal through the Sourcewell National Cooperative Contract #062222-JAL has been received; and

WHEREAS, the Public Works Fleet Services Division has determined that this contract meets all desired specifications and that the cooperative agreement proposal received is reasonable; and

WHEREAS, it is in the best interest of the City of West Allis that the proposal of MacQueen Equipment be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the proposal dated July 23, 2026 by MacQueen Equipment for furnishing and delivering one new Larue D50 loader-mounted two-stage snow blower for a total of \$245,135 is accepted.

BE IT FURTHER RESOLVED that this purchase will be charged to Account Number 352-4218-535.7003.

BE IT FURTHER RESOLVED that the Finance Department is authorized to enter into a contract for the aforesaid equipment.

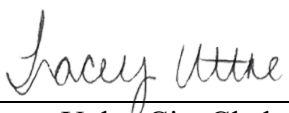

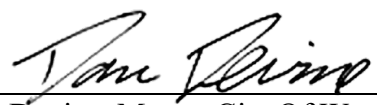
