That's correct. It is our policy in all cases.

I did send the release as soon as we reached settlement three weeks ago on 3/20.

Given that Attorney Falk provided the subrogation settlement information including a release, you can omit that part from the release I sent.

If you can provide the same subrogation release from Attorney Mundt that likely would be suitable in that regard leaving only the Troias themselves.

I do understand that the notarization part of the Troias' signatures may cause a delay in processing their release.

If you are unable to notarize your client's signatures our office would accept the executed release and photo copies or electronic photos of their driver's licenses in place of notarization.
