Sole source purchase of hydraulic press brake.

Within the Public Works Dept. Fleet Services Div. 2009 Capital Equipment budget are funds to purchase a used Hydraulic Press Brake to replace our old mechanical press brake. We use the press brake for a wide array of fabricating jobs and projects for Fleet and several of the other divisions and departments as well. Our current press brake is 1940's vintage and is in need of some significant repairs. The other concern with it is safety related. Without going into a long winded explanation, just by the sheer nature of the way this machine operates, our Safety and Insurance people are concerned. So for the 2009 budgeted we included \$20,000.00 to replace this machine.

I have again been searching the used machinery market place for close to a year now in hopes of finding just the right unit to fit our needs and budget. With the economy in the shape it is in, good used equipment is in more demand, although I did run across a few machines that looked like they may have worked but unfortunately for one reason or another; cost, distance, condition, capacity, none of them worked out. For example I have included a couple of quotations from a local used machinery dealer Wisconsin Metal Working for your review and you will see in comparison price alone puts them out of reach for our application. However I did run across one about a month ago in Illinois just outside of Chicago at Kempler Ind. which fits the bill very well; unfortunately at the time we were unable to go there to inspect it. We have since then done so and it is a very nice machine, well maintained, with minimal use, it appears that it came from a small job shop; not high production. We ran it and looked it over from top to bottom and it is in very good condition and fits our needs and application to a tee, and best of all it is priced within our budget \$18,500.00 compared to a new machine of this type and size we would be looking at upwards of a \$100,000.00. This machine is also close enough to home that transportation costs will be reasonable. We also will have to hire a crane service to unload it but even with those costs included we will still be within budget.

So with that said I highly recommend that it would be in the Departments and divisions best interests to move forward with the purchase the this used D & K 150-ton Hydraulic Press Brake as quoted by Kempler Ind. for \$18,500.00.
