RESOLUTION R-2023-0532**

**RESOLUTION TO CONSIDER A MEMORANDUM OF UNDERSTANDING
BETWEEN THE CITY OF WEST ALLIS AND FIRST-RING INDUSTRIAL
REDEVELOPMENT ENTERPRISE, INC.**

WHEREAS, the City of West Allis (“City”) has supported the development and organization of the First Ring Industrial Redevelopment Enterprise, Inc. (“FIRE”); and,

WHEREAS, the City and FIRE have formed a partnership in which City employees, have in the past, performed certain services and functions for FIRE at its request; and,

WHEREAS, the City and FIRE desire to clarify this partnership through a renewable Memorandum of Understanding (“MOU”) that outlines the scope and extent of the services to be rendered by City employees for the benefit of FIRE in the future; and,

WHEREAS, City staff worked with FIRE to draft an MOU that is hereby attached for reference as Exhibit A – Memorandum of Understanding.

NOW THEREFORE, BE IT RESOLVED, that the Common Council of the City of West Allis hereby approves a Memorandum of Understanding between the City of West Allis and First-Ring Industrial Redevelopment Enterprise.

BE IT FURTHER RESOLVED, that the City Attorney be and is hereby authorized to make such non-substantive changes, modifications, additions and deletions to and from the various provisions of the Memorandum of Understanding, including any and all attachments, exhibits, addendums and amendments, as may be necessary and proper to correct inconsistencies, eliminate ambiguity and otherwise clarify and supplement said provisions to preserve and maintain the general intent thereof, and to prepare and deliver such other and further documents as may be reasonably necessary to complete the transactions contemplated therein.
