

SUMMARY

Officer Moews reports:

On 11/08/13 at 1618hrs, I was dispatched to Bobblehedz, 5630 W Lincoln Ave for a disorderly person refusing to leave the premise. Upon arrival, I met with the bartender, Bernard B Huber MW 04/13/47, who reported the person left prior to officer's arrival. He was arguing with Huber and yelling at the patrons causing customers to leave because they were offended. Officers later made contact with Roger L Thompson MW 05/26/61 who was extremely intoxicated and yelling in the neighborhood. Thompson was arrested and booked for Disorderly Conduct and issued a citation for a court appearance of 12/16/13 at 0830hrs. He was released in the lobby without further incident.

NARRATIVE

Officer Moews reports:

On 11/08/13 at 1618hrs, officers were dispatched to Bobblehedz, 5630 W Lincoln Ave for a disorderly person refusing to leave the premise. Upon arrival, I met with the bartender, Bernard B Huber MW 04/13/47.

STATEMENT HUBER

Bernard reported the disorderly person was no longer on scene. Bernard stated he came into the bar and was extremely intoxicated. He was yelling at the patrons and demanded Bernard serve him alcohol. Bernard asked him to leave on several occasions and he refused. He continued to argue with Bernard and a few patrons left the bar because they were offended by his behavior.

Bernard described the person as a white male, approximately 50 years old, about 5'7", medium build who was last seen wearing white pants and a dark jacket. He left the bar northbound on S 56th St.

CONTACT OFFENDER (Roger L Thompson MW 05/26/61)

Officers observed a person matching the description walking on S 56th St. He was later identified as Roger L Thompson. As we pulled our squads to the curbside, Roger immediately entered the residence of 2207 S 56th St. As officers walked up the porch steps to the residence, Roger came back outside.

It was determined, Roger did know the occupants of the residence and did not just randomly enter somebody's home. He was extremely intoxicated and was yelling in the neighborhood. He stated he did nothing wrong and there was no reason for us to stop him. I asked for his identification and he stated he was from the FBI agency and he was going to sue us. Roger was very loud and was asked on several occasions to lower his voice. At that time, a male party approached officers on the sidewalk.

Officers made contact with Dale A Thompson MW 06/18/63. He is Roger's brother and resides at 2167 S 56th St. Dale apologized for Roger's behavior and stated he would take responsibility for Roger so he wouldn't get arrested for Disorderly Conduct. At that time, Roger was turned over to Dale with no problems.

RE-CONTACT OFFENDER

Approximatey ten minutes later, Dale called the police to report Roger was uncontrollable and ran out of the house yelling and screaming. Officers found Roger in the 1900 block of S 56th St where he was taken into custody for Disorderly Conduct.

ARREST/BOOKING

Thompson was arrested and booked for Disorderly Conduct. He was fingerprinted and a booking photo was taken of him under booking # 2013005252.

POLICE CUSTODY

While Thompson was in the cell, I was advised by Captain Evenson that he fell asleep on the bed and urinated himself. I was also advised he stood up in his cell and urinated on the floor. It was determined to issue Thompson another citation for Disorderly Conduct.

MUNICIPAL CITATION

Thompson was issued municipal citation M13005251 for Disorderly Conduct at Bobblehedz. He was also issued municipal citation M99898 for Disorderly Conduct for urinating in the police cell. Both citations have a court appearance of 12/16/13 at 0830hrs. He also signed the PR bonds.

CASE DISPOSITION

Thompson caused a disturbance at Bobblehedz Bar and in the neighborhood on 56th St. He was released in the lobby without further incident.
