

**CITY OF WEST ALLIS
RESOLUTION R-2021-0147**

**RESOLUTION RELATIVE TO ACCEPTING THE CONTRACT OF RHYME
ENTERPRISES FOR PROVIDING MANAGED PRINT SERVICES FOR A 5-YEAR
PERIOD, AT A COST OF AN ESTIMATED \$79,000 PER YEAR, FOR A TOTAL NET
SUM OF \$395,000**

WHEREAS, The majority of the current printers/copiers in the City were purchased as part of a lease/servicing contract with Impact Networking 5-plus years ago and now are at end-of-life and the contracts with Impact have expired; and

WHEREAS, The City recognized that the current number of printers/copiers (117 in total) were more than what was needed given recent investments in technology, so a printer consolidation effort was conducted to lower the number of devices needed going forward; and

WHEREAS, The City of West Allis issued a Request for Proposal to find the next Managed Print Services provider for the City and Rhyme Enterprises had the lowest cost proposal and satisfied the other selection criteria defined in the RFP; and

WHEREAS, the efforts to consolidate the fleet of devices and the open bidding process will result in a savings of roughly \$120,000 annually for the City;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the contracts dated March 9th, 2021 for providing Managed Print Services to the City for the estimated sum total of \$395,000 from Rhyme Enterprises over a 5 year term be and is hereby accepted. The account where this will be charged to is account # 100-1101-517-30-13.

BE IT FURTHER RESOLVED, that the Finance Department be and is hereby authorized to enter into a contract for the aforesaid services.
