

NARRATIVE

INITIAL CALL

On 07/12/13 at 2208 hours, officers were dispatched to the 6500 Bar at 6500 W Greenfield Ave for the report of people smoking in the bar. Upon arrival at the bar, I observed a white male subject standing behind the bar and smoking a cigarette-size object. I entered the bar and the subject identified himself to me as Scott R Jesion, m/w, 07/19/61.

SCOTT'S ON-SCENE STATEMENT

Scott initially denied standing behind the bar or smoking anything inside the bar. Officers were unable to locate a bartender among the subjects inside the bar. I proceeded behind the bar to see if anyone was laying on the floor or the cash register had been emptied. I failed to locate anyone behind the bar and I observed money on the counter behind the bar. I also observed two rolled cigarettes on the same counter that contained a green plant-like substance. I questioned Scott about the items and he initially stated he found the items in the bar and placed them on the counter.

Scott admitted to standing behind the bar only because the bartender left the business early. Regarding the suspected marijuana cigarettes, Scott eventually admitted the items were synthetic marijuana and they belonged to him. He said he had a package of synthetic marijuana on a shelf behind the bar. I located a package of "Scooby Snax" synthetic marijuana. Scott was taken into custody for possession of synthetic marijuana and smoking in a bar. I placed him into handcuffs, checked them for proper fit, and safety locked them. I searched him incident to his lawful arrest with negative results and placed him into the back of my squad car. I transported him to the West Allis Police Department (WAPD.)

BAR LICENSE

Officers Steffen and Baumgart remained on scene to inquire about the absent bartender and the business' liquor license. I was later instructed by Officer Hurley to issue the bar owner (Susan C Jesion, f/w, 02/23/33) a citation for allowing an unlicensed person to operate a licensed premises without a

licensed person on the premises. Susan was mailed municipal citation M130032481. This citation has an optional municipal court date on 08/19/13 at 0830 hours. SCOTT'S MIRANDIZED STATEMENT

Upon arrival at the WAPD, SCOTT had his belongings inventoried and he was placed into an interview room. I entered the room with a digital recorder P10 that contained a digital media card P10-4. I read him his Constitutional Rights from a Constitutional Rights card provided to me by the WAPD. Scott informed me he understood his Rights and he did not want to make a statement.

PROPERTY

I entered the two synthetic marijuana cigarettes and the package of Scooby Snax in a property locker under property #13-005173-0.

BOOKING/DISPOSITION

Scott was booked for possession of synthetic marijuana and smoking in a bar. I issued him citations M130032231 and M130032232, respectively. Both of these citations have an optional municipal court date on 08/19/13 at 0830 hours. Scott was returned his property and released. I was advised a SIU order-in is not needed for possession of synthetic marijuana.

NARRATIVE

Ptm. Steffen reports...

INITIAL CALL

On 07/12/13 at approx 2208 hours, officers responded to the 6500 bar, 6500 W. Greenfield Ave., for an anonymous complaint of parties smoking inside the tavern and the caller believed the bartender was selling drugs from behind the bar. Officers arrived on scene and observed there was no bartender on scene or anyone with a bartenders license. While officers were speaking with parties inside the bar, I checked the tavern's Class B beer and Class B liquor license.

LICENSE CHECK

I observed the Class B beer and Class B liquor license (license #12-00001642) was valid from 07/01/12 and expired on 06/30/13. The license was for 6500 Bar LLC, with Susan C. Jesion as the agent. I went over and spoke with Scott R. Jesion, who advised his mother owned the bar. Scott told me the license has been okayed by the City of West Allis but there was a plumbing issue which needed to be addressed and was fixed. Scott stated all that is needed is for someone from the City of West Allis to check the plumbing was done properly and his mother should have the license.

Scott could not provide proof of a license while on scene as he continued to assure me the license has already been granted.

Due to the tavern not having proof of a valid Class B beer and Class B liquor license, the tavern was shut down until they had proof of a valid Class B beer and Class B liquor license.

Appearance by Susan C. Jesion. Ald. Czaplewski told Ms. Jesion that he does not believe the business is being run like Ms. Jesion said it was going to be when she appeared before the Committee to receive her Class B Tavern License. He reminded her that Scott Jesion was not to be involved in the operation of the business, and she was supposed to have a food menu and a bar manager. Ald. Czaplewski said he understands Jill Huennekens' story is just one side of what happened, but cannot ignore what else is going on there. Ald. Weigel said he stopped in the establishment one evening and Scott Jesion was tending bar. He was behind the bar pouring, serving and accepting payment for orders. Ald. Weigel said he did not see another bartender behind the bar while he was there. Ms. Jesion replied that she orders and runs the bar. Scott Jesion is at the establishment before closing time to make sure the bartenders are escorted safely to their cars. Scott Jesion is still doing repairs to the outside of the building and the kitchen area is next on the schedule. She informed the Committee that she cannot serve food until the kitchen repairs are completed and approved. She said the bartender, Katie, on duty the evening in question was in the ladies' room because she was not feeling well, and then she was sitting at the end of the bar. Ald. Sengstock reminded Ms. Jesion that Scott Jesion should not be in the bar area, especially not bartending. He asked how many bartenders she currently has working for her. Ald. Barczak questioned if she knew who she ordered liquor from. Ms. Jesion replied she has a full time job and relies on her employees, currently numbering three (3) bartenders. She recently let one bartender go because she was stealing. She orders from Badger Liquor. Ald. Barczak asked who else she orders from because he has seen other vendors' trucks there. She said she did not order from anyone else.
