I am writing to inform you that effective with our customer's March 2007 billing statement, the FCC Regulatory Fee, which is currently \$0.06 per month, will increase to \$0.07 per month. The FCC Regulatory Fee is paid directly to the Federal Communications Commission (FCC) to recover annual costs of its enforcement, policy and rulemaking, user information and internal activities. We will begin notifying customers through bill messages January 25, 2007 – February 24, 2007. The message will read:

 "Please be advised that the Federal Communications Commission FCC (FCC Fee) will increase from \$0.06 per month to \$0.07 per month. This change will be effective with your next billing statement"

Additionally, the Federal Universal Service Fund (FUSF) has been adjusted. This rate is adjusted quarterly by the FCC. The Federal Universal Service Fund helps keep local phone rates affordable for all Americans.
