Ms. Jimenez, Ms. Janusiak and Dr. Roberts commented on the presentation. Proposed declaration was reviewed and discussed. Dr. Roberts asked how this resolution will be used and suggested it be brought to Council. Ald. Tenorio agreed and offered to bring it to council. Mr. Leischow reviewed the action steps within the declaration.

- *Diane Dubey retired and efforts are underway to recruit for a Public Health Nurse.*
- *Moving forward with community health assessment (CHA)/community health improvement planning (CHIP) process. Key informant interviews are underway. Members were informed that this is a process that helps to identify health needs and determine priority areas.*
- *Noted that the Milwaukee Health Care Partnership has also started their every three year community health needs assessment process, which local health departments will be part of.*
- *COVID clinic update- clinic is going well and we continue to provide COVID vaccine to our community each week. Dr. Roberts and all BoH members expressed their appreciation and support of staff and volunteers working in our COVID vaccination clinics.*
