The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of February 2018:

INCIDENT REPORTS:

CASE #18-004038// 1 February 2018 at 0213hrs// Dopp's Bar and Grill- 1753 S 68 St
NO TAVERN VIOLATION

Caller: Angela L Etzel- Victim

ROBBERY: On 02/01/18 at approx. 0213hrs., officers responded to Dopp's Bar and Grill, 1753 S. 68 St., for an armed robbery. Investigation revealed a male suspect approached the bartender (Angela L. Etzel F/W [REDACTED]) as she was taking out the trash, held a black semi-automatic pistol against her side, and forced her into the business. The suspect demanded money, and was given approx. \$164.00 in cash before fleeing out the rear door on foot. Suspect was described as a M/W in his early 20's, approx. 6'00" thin build, blue eyes, wearing a grey hooded sweatshirt, blue jeans, and a red bandana covering his face. The business owner's son, Marcus A. Dopp M/W [REDACTED], is listed as a suspect based on previous incidents and physical description. Marcus Dopp was taken into custody as a result of this investigation.

NO TAVERN VIOLATION

ATTEMPTED ROBBERY: On 02/02/18 at approximately 1200 Hrs, Carol Powell, F/W DOB: [REDACTED] called to report a robbery that occurred on 02/01/18 at approximately 0030hrs. Powell stated while she was bartending at Studz Pub a male party around 5'11" who had his face covered with a bandana possibly red in color and a dark colored hoodie held a gun to a customer. Powell believed the gun was fake stating it looked like a black water gun. She picked up a stick from behind the bar and told the party "You stupid mother fucker. You better get the fuck out of my bar or I'll beat the fuck out of you!" The male party fled South on S 69 St. Powell stated she was in disbelief and they did not call police at that time. She thought the offender was white as he did not sound black. She had no further information. This case may be related to case 18-004038

NO TAVERN VIOLATION**

USE OLEORESIN DEVICE-BODLY HARM/ FELON POSSESS OLEORESIN/ DISORDERLY CONDUCT: On 02/02/18 at 2159hrs., officers responded to Uncle Festers, 5732 W Mitchell St., regarding a party being pepper sprayed. Contact was made with Timothy E Wergin M/W [REDACTED] who stated he got into an altercation with Santos L Hernandez M/W [REDACTED] who was highly intoxicated. During the altercation Santos pulled out a container of pepper spray and sprayed Wergin in the face and upper body causing him pain. Santos fled the scene prior to officer arrival and was later taken into custody and was in possession of the pepper spray. He was arrested for Intent Use Oleoresin Device-Bodily Harm, Felon Use Oleoresin Device, and Disorderly Conduct. He was unable to post the required bail and was transported to the Criminal Justice Facility. The Milwaukee County DA's Office is set to review this case on 02/04/18 at 0830hrs.

NO TAVERN VIOLATION**

DISORDERLY CONDUCT: On 02/08/18 at approximately 0157hrs, offices responded to Limanskis Pub, 8900 W Greenfield Ave, for a report of a bar fight. Investigation revealed Cirilo Luis Camacho (M/H [REDACTED]) initiated the physical altercation by spitting in Jennifer M. Keliipio's (F/W [REDACTED]) face. This stemmed from a billiards game, which lead to multiple individuals physically fighting. It was determined there were four individuals who caused the disturbance - Cirilo being one of them. Cirilo was found hiding in the basement. The three other individuals Cirilo was with fled the scene before officer arrival. Cirilo was arrested and issued a Municipal Citation for Disorderly Conduct. Cirilo was given a local court date of 03/19/18 at 0830hrs.

POSSESSION/CONSUMPTION OF ALCOHOL BY PERSON 17-20/ UNDERAGE PERSON ENTER/ATTEMPT LICENSED PREMISES: On 02-10-18 at 2353 hrs, officers were waived down by the bartender at Fiddler's, 6108 W. Burnham St, regarding an underage person entering the premises. Investigation revealed Mariano A. Gonzalez Jr. (m/h, [REDACTED]) entered Fiddler's tavern and was refused service. Gonzalez admitted he consumed alcohol at his residence. He was issued municipal citations for both offenses. An NCIC/CIB check revealed he had four final commitments for his arrest through the West Allis Police Department. Gonzalez was unable to post bond and transported to HOC.

**CASE #18-005212// 11 February 2018 at 0232hrs// Z's Bar- 6309 W National Ave
ALLOW PATRONS TO LEAVE WITH OPEN INTOXICANTS**

VEHICLE COLLISION INVESTIGATION: On 02/11/18 at 0232hrs, officers responded to a car vs. pedestrian in the 6300blk of W. National Ave. Investigation revealed Victoria L. Soulier, F/W [REDACTED] exited Z's bar holding a beer bottle and appeared intoxicated. She crossed the street in the middle of the block and was struck by a WI Reg; 672WGF. Soulier suffered unknown injuries to her leg and was conveyed to AWAMC. The roads were snow covered and the striking vehicle did not appear to be speeding per surveillance video. Soulier was cited as a result of this incident. It should be noted that another unknown male exited Z's bar prior to Soulier and he too was carrying a bottle of beer. There was video of the incident placed on property.

CHAPTER 51/ EMERGENCY DETENTION: On 2/23/18 at about 0241hrs, officers responded to Alibi Bar 6540 W Grant St for an intoxicated party refusing to leave the bar. While responding to the call, I observed a black male, later identified as Quintin O. Wynn M/B [REDACTED] walking east in the middle of the road in the 6400blk of W Beloit RD. I observed the male attempt to jump in front of a westbound vehicle and punch another moving vehicle. Contact was made with Quintin who explained he is homeless and wants to die. Quintin asked officers repeatedly, to shoot him. Quintin was placed under emergency detention and transported to MCMH for a mental evaluation.

CASE #18-007403// 28 February 2018 at 1705hrs// JC's Pub- 8028 W National Ave UNLICENSED BARTENDER


Caller: Officer Initiated Tavern Check
