**NARRATIVE****STATEMENT-SHARON ALEXANDER**

On 01/30/15 at 1332 hours, I conducted a tavern check at Gussler's, 7408 W Walker St. I made contact with bartender Sharon Alexander and asked to see current liquor license. The one displayed in the tavern had expired 06-30-14. Sharon contacted the owner Eric Millard, because she could not find the current license.

**STATEMENT-ERIC MILLARD**

I spoke to Eric over the phone. He indicated that he applied for the license but had not picked the license up from City Hall.

**CITY HALL FOLLOW UP**

I made contact with City Clerk Ann Neff, who indicated that Eric had applied for liquor license on September 11, 2014. The liquor license was not approved as Eric had not fulfilled the requirements to obtain the license.

I advised Sharon to close the business until license can be obtained.

**CASE DISPOSITION**

On 02/02/15, Per Lt. Johnson, Eric Millard fulfilled all requirements and was given the Class B liquor license and can remain open. No further police action necessary. A tavern report was also completed.
