

**CITY OF WEST ALLIS
RESOLUTION R-2024-0067**

**RESOLUTION TO AUTHORIZE THE PURCHASE OF PROTECTIVE GLASS
LAMINATE AND INSTALLATION FROM SAFE HAVEN DEFENSE**

WHEREAS, the Police Department has determined that the installation of bullet resistant laminate at the Police Department and riot control laminate at West Allis City Hall will dramatically increase protection against glass breakage due to burglaries, riots, bullets, and severe weather which will also reduce possible injuries to employees and citizens; and,

WHEREAS, the West Allis Police Department has received a quote from Safe Haven Defense, utilizing the 1GPA cooperative purchasing contract to install bullet resistant laminate on four windows at the Municipal Court Lobby for \$9,456.12, to install bullet resistant laminate to the front entry glass, lobby glass and employee entrance door at the West Allis Police Department for \$42,818.24, to install riot control laminate on the front doors and four windows of City Hall, including the Customer Service lobby for \$23,845.39, and install riot control laminate on the interior doors of City Hall leading into the Council Chambers on the first floor, and the interior doors leading to the Art Gallery on the ground floor for a cost of \$9,954.91, for a total cost of \$86,074.66; and,

WHEREAS, the Purchasing Department has researched the vendor pricing and offering of Safe Haven Defense to be fair and reasonable; and,

WHEREAS, the funding for these items was approved in the 2024 Capital Budget; and,

WHEREAS, this initiative will be funded from the CIP- Buildings and Facilities, General Capital Projects, Public Safety, Contractors, and charged to account # 354-6053-523.31-01 for the Police Department, and from the CIP-Buildings and Facilities, General Capital Projects, General Government, Contracts, and charged to account # 354-6051-517-31.01 for work performed at the Court Center, and City Hall.

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the purchase of the above-described items, for an amount not to exceed \$90,000.00, is hereby authorized.
