In 2008, you received a copy of SEWRPC Planning Report No. 50 (PR No. 50), *A Regional Water Quality Management Plan Update for the Greater Milwaukee Watersheds*, published in two parts and dated December 2007. We recently issued an amendment to PR No. 50 that sets forth limited revisions to the report based on changes to the watershed water quality models necessitated by findings during additional modeling efforts conducted after the report was issued. Those modeling efforts were conducted under a separate study directed toward evaluating the possible effects of climate change on water quality in the streams of the study area.
