**RESOLUTION APPROVING REVISIONS TO THE NEIGHBORHOOD SMALL
GRANTS PROGRAM**

WHEREAS, the Mayor and Common Council of the City of West Allis, along with staff and citizens, recognize the importance of developing and maintaining healthy neighborhoods throughout the community; and,

WHEREAS, the Common Council of the City of West Allis under Resolution R-2014-0099 the City of West Allis Neighborhood Small Grant Program provides small grants to organize emerging neighborhood associations and support established associations achieve their community improvement goals; and,

WHEREAS, a Neighborhood Leadership Alliance was formed to work collaboratively with the City to provide input on policies and procedures that impact the work of neighborhood associations; and,

WHEREAS, City staff and neighborhood leaders worked together to review the small grants program and recommend policies and procedures that would build stronger relationships, increase trust, streamline the grants process, optimize opportunities, and increase program accountability, consistency, and clarity (Exhibit A).
