PLEASE TAKE NOTICE of the following circumstances of injury, filed and served on behalf of Cristina Gonzalez, D.O.B. 10/11/1986.

On September 18, 2024, Cristina Gonzalez, born October 11, 1986, and Nahlanny Rivera Gonzalez, born December 2, 2009, were injured in in a motor vehicle crash caused by Stacy Elizabeth Walter, who at all relevant times hereto was, upon information and belief, a West Allis-West Milwaukee School District employee. The motor vehicle crash occurred in the school parking lot, on Franklin Elementary School property.

On the afternoon of September 18, 2024, Cristina Gonzalez and Nahlanny Rivera Gonzalez were injured by a West Allis-West Milwaukee School District employee, Stacy Elizabeth Walter. Ms. Gonzalez was legally parked in a handicap parking spot in the parking lot of Franklin Elementary School while she was picking up her son from school. Ms. Gonzalez and Ms. Rivera Gonzalez were occupants of a legally parked car. Meanwhile, West Allis-West Milwaukee School District employee, Stacy Elizabeth Walter, exited the school building, walked to her car located in the same parking lot, and got into her car, all while she was talking on her cell phone. Ms. Walter then began to back her car out of a parking spot in a rapid and unsafe manner, causing Ms. Walter's car to


slam into the rear of Ms. Gonzalez's car, which was still parked at the time. Ms. Gonzalez and Ms. Rivera Gonzalez suffered injuries as a result of Ms. Walter's actions. Upon information and belief, Stacy Elizabeth Walter was acting in the course and scope of her employment at all times relevant hereto.

This notice of circumstances of injury is being filed pursuant to Wis. Stat. Sec. 893.80(1d)(a) and does not limit or restrict any federal civil rights or constitutional claims in any way.
