

Resolution to transfer \$126,500 from the Contingency Fund to the Public Works Department's Equipment Account for the early purchase of the two 2007 heavy-duty tandem dump truck chassis.

WHEREAS, the Public Works Department annually budgets for the replacement of its equipment; and,

WHEREAS, the Public Works Department is scheduled to replace two heavy-duty tandem dump trucks in both 2006 and 2007; and,

WHEREAS, a significant savings can be realized by purchasing the two 2007 trucks at the same time as the 2006 trucks; and,

WHEREAS, the Public Works Department's 2006 Budget has insufficient funds to pay for all four trucks; and,

WHEREAS, in a letter to the Common Council dated April18, 2006, the Director of Public Works requested the transfer of \$126,500 from the Contingency Fund for the purpose of two tandem truck chassis that were scheduled for replacement in 2007; and,

WHEREAS, on April 18, 2006, both the Administration & Finance Committee and the Public Works Committee unanimously agreed with this request.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that \$126,500 is hereby approved for transfer from the Contingency Fund to the Public Works Department's Equipment Account for the early purchase of the two 2007 heavy-duty tandem dump truck chassis.

BE IT FURTHER RESOLVED that this \$126,500 transfer shall be paid back to the Contingency Fund by the Public Works Department's 2007 Equipment Account.

Re: 2007 Public Works Equipment Purchases

Honorable Mayor and Council Members:

The Public Works Department annually updates its three-year equipment replacement listing in preparation for the following years budget process. In 2007, we are scheduled to replace two heavy-duty tandem dump trucks, identical to two that we are replacing in 2006.

In 2007 the next tier of federal emission standards kicks in for on highway truck diesel engines. Specifically, next year's engines will necessitate the incorporation of a diesel particulate oxidation catalyst exhaust after treatment device being added to all on highway diesel engines. In and by itself, this is projected to add between 7 and 10 percent to the price of a chassis over and above the normal 2 to 3 percent annual price increase. Maintenance costs will also increase.

Like all price increases, the projected 10 to 13 percent increase would be difficult to absorb. Unfortunately, the problem for the Public Works fleet is magnified by the fact that the standard engine in our fleet, the Caterpillar C-7, will no longer be offered by any of the chassis distributors due to insurmountable engineering constraints imposed by the addition of this mandated device to the exhaust system. We have a couple of different choices, both of which will be costly. First, we can switch to another manufacturer. This will result in various short term and long term impacts including the retooling of our equipment, software and retraining of our technical staff. The second option would be the purchase of the CAT C-11 engine which, while giving additional power, (which we do not require) would also add another ten percent to the cost of the chassis and increase operating expenses.

The Department would like to propose a third alternative. As noted above, we currently have two chassis on order with the Cat C-7 engine. We have spoken to our vendor and he has informed us that the \$63,206 price that we paid for each of these chassis will be locked for us if we choose to order additional chassis. We would, however, have to order

these chassis within the next month to assure that our order can be placed in the build'line for the plant this year.

In view of the anticipated 2007 price increase and our ability to secure two truck chassis this year at a projected savings of approximately \$12,000, I respectfully request that \$126,500 be transferred to the Public Works Department from the contingency fund for the purpose of purchasing two additional tandem truck chassis this year. The transferred money will be paid pack from 2007 budget funds. I should note, that it is highly unlikely that the funds will actually be spent this year. Rather, we hope to be able to schedule production of these two chassis for the latter part of the year. This would mean that delivery and payment would not be made until some six months later. Nonetheless, the order must be placed now to assure production and therefore, money must be encumbered for the order.
