**RESOLUTION TO APPROVE THE BID OF VISU-SEWER, LLC FOR SANITARY  
SEWER SPOT LINING AND GROUTING AT VARIOUS LOCATIONS IN THE CITY  
OF WEST ALLIS IN THE AMOUNT OF \$193,630**

**WHEREAS**, the Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of Visu-Sewer, LLC for 2025 Project No. 15 be accepted.

**NOW THEREFORE**, be it resolved by the Common Council of the City of West Allis that the bid of Visu-Sewer, LLC for 2025 Project No. 15 for the trenchless repairs of sanitary sewers at various locations within the City of West Allis for the sum of One Hundred Ninety-three Thousand, Six Hundred Thirty and no/100 dollars (\$193,630) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

**BE IT FURTHER RESOLVED** that said improvements be installed with funding by Sanitary Sewer Funds 510-3803-536.75-01




