**RESOLUTION TO APPROVE BID OF WIL-SURGE ELECTRIC, INC. FOR S. 96TH  
ST. PUMP STATION GENERATOR IN THE AMOUNT OF \$384,132**

**WHEREAS**, The Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received as shown on the attached bid report were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of WIL-Surge Electric, Inc. for 2024 Project No. 34 be accepted.

**NOW THEREFORE**, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of WIL-Surge Electric, Inc. for 2024 Project No. 34 for providing and installing a new diesel emergency generator, transfer switch, and interconnections at the South 96th Street Pump Station Generator located at:

West Allis, WI 53214  
(PLAN FILE NOS. B-841)

for the sum of Three Hundred, Eighty-four Thousand, One Hundred, Thirty-Two and no/100 dollars (\$384,132) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED that said improvements be installed with Water Utility Funds and Safe Drinking Water Loan Program Funds.
