

## NARRATIVE

#### INITIAL CALL/OBSERVATIONS

On 03/29/14 at approximately 0225 hrs, officers responded to Brooklyns Gentlemen's Club 9440 W. National Ave. for a weapons call. Dispatch informed responding officers the offender had left in a black BMW north on S. 95 St. As I arrived on scene, I observed a M/W later identified as William N. Johnson (M/W, 08/23/84), standing in the middle of S. 95 St. with a white towel wrapped around his left forearm soaked in blood. William removed the towel and I observed a small puncture wound on his left forearm approximately two inches long. I immediately called for a med unit to respond to my location to have the wound on William's forearm looked at.

## STATEMENT OF WILLIAM N. JOHNSON

William stated he arrived at Brooklyns at approximately 0130 hrs, with his girlfriend Maria B. Ebecchetti (F/W, 01/18/92), and his friend John D. Smith (M/W, 03/30/86), to celebrate John's birthday. They were only there for approximately an hour, and decided to leave. As they were walking to William's vehicle, which was parked on the west side of Brooklyns, William heard someone behind him "moan," or "mumble," he turned around to see a male later identified as Nicolas R. Natarelli (M/W, 04/23/74), wearing a black coat and jeans following him. Without saying a word to William, Nicolas pulls an object from his right pocket.

Once the object is in Nicolas's right hand, he makes quick movement with his hand, and lunges at William. Not knowing what is in Nicolas's hand, William puts his left arm up to protect himself from Nicolas. After Nicolas lunged at him, William was able to take a

few steps back to create some distance between himself and Nicolas. William advised me Nicolas continued to stagger towards him slowly waving a knife back and forth. I asked him was the knife pointed at him and he replied, "Yes." William described the knife as a folding knife with a blade approximately two to three inches long. As William was backing away from Nicolas, he observed his left hand was covered in blood, and realized he had been stabbed. He yelled to John and Maria he had been stabbed, and John grabbed him and walked him to the driver's side of William's vehicle.

As they were Standing by the driver's side door, Nicolas continued to walk towards them until he saw the crowd that was gathering on the corner of S. 95 St/W. National Ave. Nicolas began to walk north on the sidewalk away from William. As Nicolas reached Brooklyns parking lot, which is located on the north side of the building, John ran after him to try and stop him from leaving. As John approached Nicolas, he turned around and begins to walk toward John. Seeing this William yelled to John to get away from Nicolas, because it was not worth getting hurt over. As soon as John began to walk away from Nicolas, he turned and walked north on S. 95 St. I asked William if he had seen where Nicolas had gone, or if he could tell me anything else about Nicolas and he replied, "No, all I could think about was my six year old son."

#### ARREST DECISION/TRANSPORT

Based on William's statement and injuries, and witness statements and description of the offender, and Nicolas admitting to being at Brooklyns and getting into the passenger seat of Keith's BMW, he was arrested for 1st Degree Recklessly Endangering Safety. Nicolas was handcuffed, searched, and placed in the back of Officer Kuhnmuench's squad to be transported back to the station for the booking process.

## FOLLOW UP INVESTIGATION AT 3367 S. 68 ST

On 03/29/14 at approximately  $0325 \, hrs$ , Officer Mathy and I made contact at  $3367 \, S$ .  $68 \, St$ , in the City of Milwaukee, as the license plate on the suspect vehicle listed to this residence. The suspect vehicle license plate listed to a Gladys L. Petrovic, F/W, 05/20/30,  $3367 \, S$ .  $68 \, St$  and a Rebecca A. Gumhold, F/W, 05/19/83 with a Saint Germain, WI address. The DOT response stated that there was no vehicle associated with the license plate. We did not find the suspect vehicle parked at the residence.

## CONTACT WITH DENISE MALDONADO

A female, identified as Denise J. Maldonado, F/W, 10/25/50, opened the door and allowed us inside. Denise stated that she lived at the residence with her elderly friend, Gladys Petrovic. Gladys was also present, but was sleeping. Denise told us that no one else was in the house.

Denise stated that she had no idea why we would be at her house. She admitted to knowing Rebecca Gumhold and stated that Rebecca was Gladys' granddaughter. Rebecaa lived "up north" and would occasionally come down and visit Gladys, but that Rebecca hadn't been around in several months. We briefly informed Denise about our investigation and why we were at her house. I specifically asked Denise about anyone at the house owning a Black BMW vehicle. Denise acted confused and stated, "no."

At our request, Denise woke up Gladys. Officer Mathy then spoke with Gladys in the family room, while I spoke separately with Denise in the kitchen.

and I then asked Denise about this and she confirmed that Gladys' grandson lived in the basement and that he drove a Black BMW. Denise told me that she was still "groggy" and sleepy when she initially told me that no one owned a BMW.

Denise identified the male as Keith C. Kreil, M/W, 12/23/75 and that he owned a 1992 BMW. She provided further identification about Keith to Officer Mathy.

Denise gave officers consent to search the basement for Keith. Officers checked downstairs, but did not locate anyone. I did notice in plain view in the basement on top of a bar table, a paper document which was a automotive work order form. The work order was from Maynard's Automotive, (4061 W. Loomis Rd, Greenfield, WI #414-282-6015), dated 03/08/14 with a payment date of 03/24/14 written across the form. The work order was for various repairs to a 1992 BMW 535I, with VIN #WBAHD131XNBF12913, with the owner name, address and phone numbers being listed as Keith C. Kreil, 3367 S. 68 St, Milwaukee, WI 53219, #262-227-8432 and #414321-0229.

## PHONE CONTACT WITH KEITH KREIL

While Officer Mathy and I continued to speak with Denise her residence, I called Keith' cell phone. Denise had given Officer Mathy Keith's cell phone number of #262-227-8432, which matched the number I observed on the automotive work order form in the basement.

At 0400hrs, I called this number and it went to a voicemail box that wasn't currently set up. At approximately 0401hrs, I received a call back from this same phone number.

I spoke with a male who identified himself as "Keith". I briefly told Keith that I was investigating a large disturbance at Brooklyn's and that I needed to speak with him. Keith voluntarily stated, "Is it about the stabbing?" He continued by telling me that he was in his car, heard people screaming about someone being stabbed and then he drove off. He told me several times that he didn't know anything about it.

I told Keith that I needed to speak with him in person. Keith agreed to speak with me, but was initially evasive in telling me where he was. Keith stated that he was just walking around and that he was lost. He eventually told me that he was on Bluemound Road near 97th Street. After going back and forth with Keith for several minutes, I told him that I knew he had a Black BMW. Keith admitted to driving the BMW, but stated that he parked it "awhile ago" and couldn't remember where. He didn't want to be driving, as his license was suspended. He told me that he parked his BMW about "10 blocks away" and that he just started walking around. Keith stated he was currently by himself and didn't know where he currently was. At my request he described what he was

wearing, being a brown jacket, black pants, no hat and stated that he had brown hair.

As I continued speaking with Keith, I relayed the information to Officer Mathy who broadcast Keith's possible location of 97/Bluemound and description to other squads. Other WAPD Officers began responding to that location in an attempt to locate Keith.

Keith continued to provide me various business names, but wouldn't give me an address of any of the businesses. He then told me that he was walking to a stop light in an attempt to provide a street sign. After several minutes he stated that he was at Pilgrim Road and W. Moorland Road, (City of Brookfield). This updated information was given to WAPD Officers and dispatch notified Brookfield PD as well. Shortly thereafter, WAPD Officers, Brookfield PD and a WI State Patrol Trooper located Keith at the above location and took him into custody without incident.

Officer Kuhnmuench also notified me that they had located the Black BMW parked very close nearby.

#### INITIAL RESPONSE

On 3/29/14, at approx.  $0224 \, \text{hrs}$ , Officers responded to Brooklyn's,  $9440 \, \text{W}$ . National Ave. for the report of a stabbing.

## STATEMENT BY MICHAEL E. PERLEBERG

On scene, I spoke with Michael E. Perleberg, (m/w, 3/9/71), who is a DJ at the establishment. Michael stated that everything inside of the club had been calm and he did not witness any altercation between any customers. Michael was cleaning up when a female, later identified as Maria B. Ebecchetti, (f/w, 1/18/92), ran into the business yelling, "My boyfriend got stabbed!!" Michael exited the club with a Security Officer and walked westbound on W. National Ave. to S. 95th St. where he observed Maria yelling, "He is right there!" Michael advised that Maria was referring to the person who stabbed her boyfriend, later identified as Nicolas N. Johnson, (m/w, 8/23/84.)

Michael then walked northbound on S. 95th St. to a parking lot located behind the business and stood behind a black BMW, WI-Reg: 685-FJZ, that Maria was pointing to. The vehicle was parked just north of the back parking lot. Inside of the vehicle, Michael observed 2 people inside of the vehicle, one person sitting in the front passenger seat and one person sitting in the drivers seat. Michael was unable to positively identify the race of the parties in the vehicle because of the darkness, but thought they might be Hispanic. Both of the occupants looked straight at Michael, however he was only able to provide a clothing description of "dark shirts." At no time did Michael see either party enter the vehicle.

While observing the vehicle, Michael was standing approx. 10 feet behind back passenger side corner of the vehicle. Michael was able to obtain the license plate of the vehicle, which was a WI-Reg: 685-FJZ. Michael described the vehicle as a black or dark blue, older model, BMW with a loud muffler. Michael did not notice any other obvious markings on the vehicle.

During my interaction with Michael, I did not detect any intoxicants on his breath and his speech was normal.

## APPREHENSION OF KEITH C. KREIL

While checking multiple locations for vehicle involved, Officer's had learned that one of the operator of the vehicle was identified as Keith C. Kreil,

Officers responded to that location and while checking the area, Sgt. Corwin advised he was on the phone with the owner of the BMW, Keith, that had an involvement with the incident. Keith was giving Sgt. Corwin updated locations as to his whereabouts. It was later learned that Keith was in the area of W. Bluemound Rd and Moreland Rd. in the city of Brookfield. While responding to the location, Sgt. Corwin advised me over the radio that Keith was out with an Officer, later to be identified as Trooper O'Connor from Wisconsin State Patrol, District 2.

Myself and Officer Kuhnmuench responded to the area and I located Keith speaking with Trooper O'Connor at the BP gas station, located at 15565 W. Bluemound Rd. in the city of Brookfield. Based on the seriousness of the offense, a knife being involved, and the fact that Trooper O'Connor did not know the circumstances surrounding the event, I immediately placed Keith in handcuffs, for investigative purposes, without incident.

Based on the fact that a knife was involved in the incident involving Keith's vehicle, I performed a search of his person. While searching Keith, I retrieved multiple "Free Passes" from Brooklyn's and also a ignition key to a BMW along with other miscellaneous items. The items were placed in a plastic bag and secured in my squad.

Trooper O'Connor advised me that shortly after coming into contact with Keith, I arrived on scene, therefore did not speak to him about anything.

## ON SCENE STATEMENT BY KEITH C. KREIL

I began asking Keith what he was doing tonight. Keith advised he was at a Strip Club, but was not sure of the name. I asked if the strip club was called Brooklyn's and he said that the name sounded right. Keith went to the strip club by himself and sat down inside. He sat next to an unknown party, whom he thinks, later identified himself as Jeremy. (It was later discovered that "Jeremy" was identified as Nicolas R. Natarelli, (m/w, 4/23/74), from here on in the report, I will be using the name of Nicolas,) Keith and Nicolas were speaking to each other when a female, described as hispanic with black hair that had her hair tied up, began speaking to Keith. Nicolas told Keith that he should, "not worry about her" and "let me (Nicolas) take care of you."

I asked Keith if he would be able to describe Nicolas's physical descriptors and he stated Nicolas was approx. 5'10, 180lbs, and possibly had blonde hair. Keith said that one specific feature that stuck out where Nicolas's teeth. Keith said he was only able to see the top 4 teeth of Nicolas's and said, "They were messed up." Keith could only describe one piece of clothing on Nicolas, and that was a black jacket.

Keith then stated later on in the night, approx. after 1 hour of being inside of Brooklyn's, he stepped outside and while outside he heard the female that

he sat next to yell, "Someone stabbed my boyfriend!" I asked Keith if he said anything back to her and he stated he was approx. 15 feet away from her and said, "Really, you're boyfriend got stabbed?" The female had no response to Keith. Keith then decided he was going to go inside and retrieve his jacket. I began going over the story with Keith again and then he advised me he was never outside of Brooklyn's because he did not take his jacket inside. I asked Keith to start over from the beginning, in which he did.

Keith began telling his story over, but instead of being outside when hearing that someone got stabbed, he was inside of Brooklyn's. After hearing about the stabbing, Keith decided to leave the establishment. Keith arrived at his parked vehicle which was parked "by the parking lot." Keith was about to get in his vehicle when Nicolas came up to him and said, "Do you need a ride home?" and "I'll drive you." Keith then gave the keys to Nicolas and they drove off. Keith then got into the passengers side of the vehicle and Nicolas in the driver's side.

I asked Keith where he and Nicolas drove to after leaving Brooklyn's and he said, "right here," without stopping at any other locations. I asked Keith how his vehicle ended up where it was currently parked and Keith advised me Nicolas had parked it here. I asked Keith what he and Nicolas were talking about while they were in the vehicle together and he said, "Nothing." but just prior to receiving the call from Sgt. Corwin, Nicolas had began saying something to the fact of, "I should have never of given my gun away." Nothing further was said regarding the gun, because Keith was now talking to Sgt. Corwin and did not have a chance to ask him about the statement.

While on the phone with Sgt. Corwin, Nicolas somehow found out that Keith was, "talking to a cop." Nicolas's facial features changed dramatically and he began to look very nervous. Nicolas pulled the vehicle to where it was currently parked and after it was parked Keith got out of the vehicle and began walking away from it in order to speak to Sgt. Corwin. When Keith turned around to see if Nicolas was still there, he stated, "He just disappeared." Keith could not give a last known direction of travel for Nicolas.

I asked Keith if there was any possibility that he drove the vehicle to his current location and he told me no. I explained to him that there are video cameras located outside of the business that the vehicle was parked behind. Keith continued to deny that he was the driver and was adamant that he was only a passenger. Keith continually denied driving the vehicle.

During my interaction with Keith, I detected a very strong odor of intoxicants emitting from his breath, his speech was thick and slurred, and his eyes were red and glassy. Based on my training and experience as a Police Officer, I believed that Keith was under the influence of an intoxicant.

#### Sgt. Zingale reports...

On 03/29/14 at 0224 hrs. I responded to Brooklynn's, 9440 W National Ave in the city of West Allis, County of Milwaukee for a report of a stabbing. Upon my arrival, I met with Maria Ebecchetti. Ebecchetti made the following statement.

## Statement/Maria Ebecchetti

Ebecchetti said that she had been at Brooklynn's with her boyfriend, William and another friend, Timothy. She stated that they arrived at the bar around 0100 hrs. Ebecchetti said while she was at the tavern, she consumed 3 shots and 2 mix drinks. Ebecchetti said they stayed until bar close.

Ebecchetti states she left the bar with William and Timothy and they began to walk toward their vehicle on S. 95 St. just north of W. National Ave. Ebecchetti said as they were walking toward their vehicle, she observed a male person walking very close to them. Ebecchetti said she noticed this person was staggering and that he appeared to be highly intoxicated. Ebecchetti admits she and her friends began to laugh at him cause the staggering appeared funny, but she wanted it made clear that they were not making fun of him.

Ebecchetti said this intoxicated male then stabbed William (her boyfriend) one time on his right wrist/arm area. I asked Ebecchetti why this person stabbed William. Ebecchetti said she did not know why he did this. I asked Ebecchetti if anyone in her group did anything to provoke the intoxicated male which would have resulted in him stabbing William. Ebecchetti said they did not do anything to provoke him.

I asked Ebecchetti what happened next. Ebecchetti said the offender (intoxicated male) began to hiss like a cat at them. Ebecchetti told me that she felt there was something wrong with the offender and she explained that he seem mentally unstable or not all there. She said he was holding a pocket knife in his right hand and he was making stabbing motions as though he was going attack William again. Ebecchetti said they ran back to Brooklynn's to get away from the offender, and they notified security of what happened. Ebecchetti said security accompanied them back to the area where William was stabbed. Ebecchetti said she then observed the offender enter a passenger side of a vehicle. Ebecchetti said the vehicle then left northbound on S. 95 St. from W. National Ave.

I asked Ebecchetti if the offender was driving the car. Ebecchetti said the offender got into the passenger seat and the vehicle was being driven by someone else. I asked Ebecchetti if she knew who the person was that stabbed William, or if she knew who the driver of the getaway car was and she said no.

### Suspect Description of Stabber (Offender)

Ebecchetti described the person who stabbed William as folllows:

M/W, approximately 5'10", medium build, with short darker colored hair, dark gotee, wearing a baseball cap, black sweatshirt with white writing and jeans. Ebecchetti said the offender was holding a pocket knife in his right hand. She told me that she could only see the blade of the knife was approximately 3 inches long. Ebecchetti said she would be able to identify this person if she saw him again.

I asked Ebecchetti if she was able to describe who drove the car away from the stabbing scene. Ebecchetti said she did not see this person. She said that she was not able to provide any description of this person.

## Suspect Vehicle Desciption

Ebecchetti described the suspect vehicle to be older, darker in color, possibly a Honda or a Hyundaii vehicle. Ebechetti said it was a Wisconsin plate and that she was pretty certain the letters of the license plate were FJZ. Ebecchetti told me that the numbers in the plate were possibly 865.

## Initial Call:

Officers were dispatched to 9440 W National Ave for a trouble call. Dispatch advise a female party reported a stabbing in front of Brooklyn's gentleman's club. I responded to the scene and assisted officers in the investigation. On scene officers were advised by several witnesses that the offender fled in a black BMW WI Plt#685-FJZ. A DOT/NCIC check revealed the vehicle listed to 3367 S 68 St, Milwaukee, WI. Officers responded to the residence and were able to obtain a phone number for the vehicle owner Keith C Kreil M/W 12/23/75. Sgt Corwin made phone contact with Kreil who initially said he was in the area of N 97 St/W Bluemound Rd in Wauwatosa. I responded to the area and attempted to locate the vehicle.

## Location of Offender's Vehicle:

After checking the area for several minutes Sgt Corwin advised via radio that Kreil was advising he was at a shopping center called Bluemound Commons (15375 W Bluemound Rd, Brookfield, WI). walking W/B on W Bluemound Rd. The officer further stated that the individual appeared intoxicated and was stumbling. The City of Brookfield PD (who were on scene) put the information over the radio and requested squads check the area. A short time later I was advised by The City of Brookfield PD that there was a Town of Brookfield Police officer out with a subject matching the description.

I responded to the intersection of W Bluemound Rd/Janacek Rd where I made contact with PO Bradley C Meyer. PO Meyer advised that he had been scanning the City of Brookfield PD radio and heard the suspect description come over the air. PO Meyer began checking the area and located a M/W (Later identified by WI DL as Nicholas R Natarelli M/W 04/23/74) stumbling in the area of Bluemound/Janacek. PO Meyer advised he approached Natarelli in full police uniform and introduced himself as a police officer. PO Meyer asked Natarelli permission to search him and he consented. PO Meyer located a folding black knife in Natarelli's right boot and several baggies of prescription drugs in his pockets. Natarelli turned over the knife to me and I walked to the back of his squad to make contact with Natarelli.

I opened the rear squad door and immediately observed Natarelli was wearing a black and red Wisconsin Badgers ball cap, black leather coat, blue jeans and UWM Panthers T-shirt. The clothing Natarelli was wearing was consistent with the witness statements from the Brooklyn's offender. I introduced myself as a West Allis Police Officer and began speaking with Natarelli. I asked Natarelli where he was coming from and he explained he had been in a vehicle down the road. Natarelli smelled strongly of intoxicants and his speech was very slurred. Natarelli stated he was driving with a friend who name he thought was "Steve". Natarelli said they were driving around looking for Taco Bell and Steve eventually pulled over in a parking lot. Natarelli explained Steve received a phone call and exited the vehicle on the phone. Natarelli said he thought he had been "dumped off" so he began walking west on Bluemound Rd.

Natarelli stated he continued walking west because he was looking for a better party. Natarelli said before being dropped off in Brookfield he met Steve at Brooklyn's in West Allis. Natarelli stated they were drinking and having a good time at the club. Natarelli said at closing time they got into Steve's car and began driving around looking for Taco Bell. Natarelli explained they drove to Brookfield to look for a party, but Steve pulled over. Natarelli stated Steve pulled over and walked off. Natarelli said he thought he had been left there so he decided to walk west. Natarelli stated he walked for a long time and then was stopped by the police officer.

I asked Natarelli if there was an altercation outside of Brooklyn's and he said there was not. Natarelli stated nothing bad happened at Brooklyn's and he had a good time. Natarelli said he left Brooklyn's because it was closing. Natarelli stated he was the passenger in Steve's car which he thought was a dark sedan.

Officer Fletcher reports...

#### INITIAL RESPONSE

On 03/29/14 at approx. 0224hrs.,I responded to Brooklyn's, 9440 W. National Ave. to assist officers on a trouble call. Maria B. Ebecchetti F/W 01/18/92 reported her boyfriend, William N. Johnson M/W 08/23/84, had been stabbed by an unknown party. While I was en route to the call, dispatch advised witnesses observed the offender flee in a dark colored BMW (Lic #685-SJZ). After arriving on scene, I made contact with Brandon A. Freezor M/W 10/28/83, who is employed by Brooklyn's as a security officer. I spoke with Freezor outside of the club regarding this incident.

## CONTACT WITH BRANDON A. FEEZOR

Feezor advised at approx. 0220hrs., he was inside of the bar area attempting to clear patrons out because they were closing. While speaking with patrons inside of the bar area, Feezor observed Maria run into the front (south) door of the bar, screaming "My boyfriend just got stabbed!" referring to Johnson. Feezor then ran to the front entrance of the business and began asking Maria what happened. Maria continued to repeat, "I don't know what happened, my boyfriend just got stabbed!" Feezor asked Maria who stabbed her boyfriend, and she answered, "I don't know, some weirdo!" After hearing this description of the suspect, Feezor advised he was "95% sure" that he knew who Maria was referring to.

Feezor advised one particular patron of the business that evening stood out to him as being "weird." Feezor described the party as a M/W, approx. 45 years old, 5'9" tall and 180lbs, wearing a red Wisconsin Badgers baseball cap and a black University of Wisconsin - Milwaukee t-shirt, with brown/red hair and a goatee. Feezor stated the above party was acting "very suspicious" throughout the evening, and advised "he wasn't all there." When I asked Feezor to described how the party was acting suspicious, he advised the party kept approaching him throughout the evening asking for "free pass" cards.

Feezor advised he was unsure how long the party was inside of the business, but stated he remembered seeing him throughout the evening. Feezor stated he did not see the above party with anyone else inside of the business, and was unsure who he came there with. Feezor did not observe the party have any confrontations with other patrons while inside.

Feezor then walked around the southwest corner of the business and looked north down S. 95 St. After doing so, Feezor stated he observed the same suspicious party standing on the sidewalk approx. halfway down the block, on the east side of the street, just to the north of the rear parking lot entrance. Feezor then turned around towards Maria, who was now standing on the northeast corner of W. National Ave./S. 95 St., and asked "Is that the guy who stabbed him?" while pointing towards the suspicious party. Maria replied, "Yeah, that's him!" confirming that the party Feezor was pointing to was the same party that stabbed her boyfriend.

After receiving confirmation that the party Feezor observed was the same party that stabbed Johnson, Feezor began walking N/B down the sidewalk to confront the suspect. Feezor stated the suspect was facing towards him, standing on the sidewalk, and appeared to be "out of it." Feezor advised he got approx. 40-50 feet away from the suspect when he observed the suspect's right hand behind his back. Fearing that the suspect may have been holding a knife behind his back, Feezor stopped, and asked the suspect, "Did you just stab someone?" After Feezor asked the suspect about the stabbing, he advised he heard the sound of a switchblade knife opening behind the suspects back coming from his right hand. I asked Feezor how he knew that the sound was a knife, and he stated he clearly heard the clicking noise that a switchblade knife makes when you open it.

Fearing that the suspect may assault him if he approached any closer, Feezor began walking backwards (south) on the sidewalk. As Feezor walked backwards, he observed the suspect walk towards him and eventually enter the passenger's side door of a dark blue/black BMW, late 90's or early 2000's model, bearing Lic #685-FJZ. Feezor then observed the BMW drive N/B on S. 95 St.

Feezor stated that prior to the suspect entering the front passenger seat of the BMW, the vehicle was only occupied by the driver. Feezor also advised that he recognized the driver of the BMW from inside of the bar, but did not see the driver or suspect together inside of the bar earlier in the evening. Feezor stated the driver of the BMW was a party that often comes to Brooklyn's, as well as Mad Dog Saloon, Feezor's other place of employment. Feezor repeated that although he recognized the driver of the BMW, he has never seen the suspect before tonight.

Feezor described the driver of the BMW as a M/W, 40-45 years old, approx. 5'10", 180-190lbs, with red/brown hair and a crooked front tooth. Feezor was unable to recall what the driver was wearing that night, and advised he could not see his clothing while he was seated in the driver's seat of the vehicle.

Dispatch advised the original license plate that was ran was #685-SJZ. Feezor stated that he was "100% positive" that the license plate that he gave me was correct. I subsequently informed dispatch of the correct license plate, which did not have a vehicle associated, and was registered to a party out of Milwaukee. Officers then responded to the registered owner's address to continue the investigation.

INITIAL CALL

Officer Mathy reports...

On 03/29/14 at approximately 0224hrs, I responded to 9440 W. National Ave., Brooklyn's bar, for a weapons call. Prior to my arrival Officers radioed that the offender fled in a black BMW. Upon arrival the scene was secure and I initiated contact with the bar owner, Dominic T. LaLicata M/W 10/16/74.

# STATEMENT- DOMINIC T. LALICATA (CONTACT)

I asked Dominic if any portion of the confrontation or physical altercation occurred inside the Brooklyn's and he said it did not. Dominic was informed by his security staff of the incident. Dominic said he observed the victim outside the bar after the incident occurred and he believes he was sitting near the south side dance floor. Dominic said no parties were asked to leave that evening and he did not observe any disturbances. I asked Dominic if he could access his security footage. Dominic said he was confident that his security camera DVR system was not operating correctly. Dominic said he can view the cameras for a live feed however he was not viewing the surveilence during the time of the incident. I informed Dominic that video surveilence was pertinent for this case and I asked him to verify the status of his video monitoring system. Dominic informed me that he will call his, information technology personnel, referred to as "IT guy," and see if he can produce the video. I provided Dominic with my business card and told him to contact me with an updated status.

On 03/30/14 at approximately  $0100\,\mathrm{hrs}$ , Dominic left a voicemail for me at the WAPD and informed me that he confirmed the DVR was not operational. Dominic said his video system is only set for a live feed and that he cannot afford to fix the DVR system at this time.

## FOLLOW UP

After speaking with Dominic I verified the license plate that was announced on scene, 685-FJZ/WI. I ran the license plate through DOT and it came back with no vehicle associated to it, however, the listed address for the owner was 3367 S. 68 St. in Milwaukee. The registration listed to Gladys L. Petrovic F/W 05/20/30, residing at the aforementioned address. I responded to 3367 S. 68 St. in an attempt to locate the BMW and verify the registration that was observed on scene.

## STATEMENT- DENISE J. MALDONADO (CONTACT)

Upon arrival I made contact with Denise J. Maldonado F/W10/25/50. I asked Denise if she recalled the license plate 685-FJZ and she said she did not. I informed Denise that the license plate was observed during an incident that occurred in West Allis and that the plate was seen on a black BMW. Denise said she was unfamiliar with the license plate and did not know who owned a BMW. I asked Denise if Gladys resided at the residence and she said she did. Denise said Gladys was elderly and currently sleeping. I asked Glady's if she knew anyone named Rebecca Gumhold, who was approximately 30 years old. Glady's replied she did know "Becky" and that she was related to Glady's. I informed Denise that I needed to briefly speak to Gladys and asked her to wake her up for me. Once Glady's was awoken, Sgt. Corwin continued to speak with Denise while I spoke with Gladys.

Corwin overhead Gladys talk about another male living in the residence and he began to inquire with Denise about whom Keith was and where he may be located. Gladys did not have any other pertinent information to add in regards to the case.

## STATEMENT- DENISE J. MALDONANDO (CONTACT)

After realizing the potential offender, or involved party to the incident may be at the residence I re-initiated contact with Denise. Denise then stated that Keith C. Kreil M/W 12/23/75, resided in the basement of their residence. Denise walked downstairs and confirmed that Keith was not home. I began to ask Denise follow up questions in regards to Keith while Sgt. Corwin verified that no other individuals were located inside the residence. I asked Denise what kind of vehicle Keith drives and she said "a BMW." I informed Denise that she earlier told me that she did not know of anyone who drives a BMW. Denise replied she was "groggy" and did not remember that Keith drove a BMW. I asked Denise to describe the BMW and she said it was a black 1992 BMW. Denise verified that Rebecca is Keith's sister, who resides in northern Wisconsin.

I asked Denise to describe what Keith looks like and she said he was a white male with short brown hair, 5'10, 180-200lbs, with the aforementioned date of birth. I asked Denise if Keith had facial hair and she said he did not. I asked Denise if Keith stays at their residence on a regular basis and she said he did. Denise said Keith has been living at their house since she arrived in early February. I asked Denise if Keith has a girlfriend or friends in the area where he will occasionally spend the night and she said he did not. Denise said Keith does not have a girlfriend to her knowledge and she does not know of anywhere else Keith may stay. I asked Denise when she last saw Keith and she said at 2230hrs, just prior to her going to sleep. I asked Denise if she knows where Keith may be and she said she did not know, explaining that she believed Keith never left the residence.

I asked Denise if Keith had been consuming alcohol when she saw him earlier in the night. Denise said she has did not see him drinking, however, Denise said Keith became very talkative and continued to complain about his mother, which she said he only does when he consumes alcohol. Denise provided me with Keith's cell phone number and Sgt. Corwin made phone contact with Keith.

While Sgt. Corwin was speaking with Keith, he informed me Keith was telling him where he was located. I relayed Keith's location, located in the 15300blk of W. Bluemound Rd., to responding squads. Keith was detained by Officer Otto and later transported to the WAPD for follow up investigation.

## MIRANDA STATEMENT- KEITH C. KREIL (WITNESS)

On 03/29/14 at 620hrs, I interviewed Keith in Interview Room A of the Detective Bureau in the West Allis Police Department. I recorded the interview with Digital Audio Recorder P17 using Digital Media Card P17-2. I read Keith his Miranda Rights using the West Allis Police Department Directive 42.016. Keith stated that he understood his rights and wanted to speak with me regarding the incident. The following is a synopsis of the interview. Refer to the digital recording for a verbatim statement.

I asked Keith to explain what occurred prior to having contact with the Police. Keith said he wanted to find a bar/ dance club and he located Brooklyn's at approximately 0100hrs. Keith said he did not realize Brooklyn's was a strip club until after he entered. Keith said he decided to stay at the club and sat down by the stage. Keith said he sat down next to a male, whom later asked for a ride outside of the bar. The male Keith was speaking of was later identified as the offender, Nicolas R. Natarelli M/W 04/23/74. Keith said he has never met Nicolas in the past and did not know his name. Keith described Nicolas as a white male, approximately 38 years old, approximately 5'11, 160lbs, and wearing an unknown baseball hat. Keith said he specifically remembered Keith's teeth. Keith said the front portion of Nicolas' teeth appeared normal however, Keith said the molar, or back teeth appeared dark and

#### abnormal.

Keith said he only sat at the stage for approximately 5 minutes and then sat at the bar until bar close. I asked Keith if he spoke with Nicolas at any time while inside Brooklyn's and he said he did. Keith said while seated at the stage he attempted to joke with a Hispanic female who was sitting next to him. Keith said the female was rude to him and he turned to Nicolas and stated "are all the girls like this in Milwaukee" and Nicolas replied "ya about 75% are." Keith said he did not speak with Nicolas again until he entered his BMW at the end of the night.

I asked Keith to explain what happened when he left Brooklyn's. Keith said his BMW was parked on S. 95 St. on the east side of the roadway, adjacent to the west side of Brooklyn's. Keith said while he was walking on S. 95 St. toward his vehicle, he overhead a female talking on the phone, stating "my boyfriend got stabbed." Keith said he attempted to speak to the female by stating "your boyfriend got stabbed?" Keith said she did not respond and that he continued to walk to his vehicle. Keith said he removed his coat from the car and was then approached by Nicolas. Keith said Nicolas offered to drive his BMW for him. Keith said he gave Nicolas the keys and that Nicolas drove him away from the bar. Keith said he sat in the front passenger seat and that they decided they were going to go to Keith's residence.

Keith said they decided to get Taco Bell, located on S. 27 St. Keith said they then decided to go to Nicolas' residence, however, Keith said he had difficulty finding where he lived. Keith said he was in the car with Nicolas for approximately 30 minutes when he received a phone call from Sgt. Corwin. Keith said Nicolas pulled the car over inside a parking lot while he spoke to Sgt. Corwin. Keith said he believed Nicolas overheard the conversation and because he noticed Nicholas' facial expression change. Keith said he then believed Nicolas may have been involved in the incident because he appeared worried.

Keith said Nicolas told him "I shouldn't have left my gun behind" or words similar to that effect. Keith said he was worried the Police though he was involved in the incident and began to walk away from his car. Keith said he provided Sgt. Corwin with as many details as possible in an effort to explain his actions that evening. Keith said he did not see Nicolas again after he walked away from the car.

I informed Keith that it was imperative that he told me the truth. I asked Keith why he would offer his car keys to someone he sat next to for approximately 5 minutes. Keith could not provide an answer. I informed Keith that numerous video cameras were located outside of Brooklyn's bar, and I also informed Keith that I was not pursuing a possible OWI investigation if he was in fact the driver. Keith then admitted that he lied about Nicolas driving his car. I told Keith to explain the correct version of the nights events.

Keith said everything he told me leading up to entering his car was the truth. Keith said after he attempted to speak with the female who stated "my boyfriend got stabbed", he entered his BMW and started it to warm it up. Keith said he was sitting in his vehicle for approximately one minute when his passenger door opened and a Nicolas entered. As Nicolas entered the front passenger seat of the BMW he stated "ok lets go, you going to give me a ride." Keith said he agreed and drove away from Brooklyn's.

Keith said he had no involvement in the stabbing and did not know Nicolas was involved in any way. Keith said Nicolas did not mention getting into a fight or stabbing anyone. Keith said he did not observe any blood on Keith and did not suspect he was involved until he observed his facial expression while on the phone with Sgt. Corwin. Keith said he originally lied about driving his BMW because it would have led to his 4th OWI arrest. I asked Keith if he observed a confrontation, disturbance, or physical altercation outside the bar and he said he did not. Keith said he heard the aforementioned female talk about he stabbing, however, he did not see anything else related to the incident.

I concluded the interview at 0701hrs. I later placed the digital media card in a secure envelope and placed in the Forensic/ Technical Services Bureau secure drawer.

## MIRANDA

On 03/29/14 at 0802hrs, I interviewed Nicolas in Interview Room A of the booking room in the West Allis Police Department. I recorded the interview with Digital Audio Recorder P17 using Digital Media Card P17-2. I read Nicolas his Miranda Rights using the West Allis Police Department Directive 42.016. Nicolas stated that he understood his rights and wanted to speak with me regarding the incident.

I asked Nicolas to explain what he did this evening from the time he entered Brooklyn's until the time he had contact with Police. Nicolas said he went out to have a couple drinks at Brooklyn's. Nicolas estimated that he arrived at Brooklyn's at approximately 0030hrs. Nicolas said he was sitting at the stage the entire time and that he drank four beers while inside Brooklyn's. Nicholas said a tall male was positioning dollar bills in a number of ways and believed the male was attempting to "show off." Nicolas later stated that he consumed numerous prescription medications earlier in the day including Percocet, Xanax, and muscle relaxers. Nicolas said he left the bar when it appeared it was closing. Nicolas said he "somehow ended up in a stranger's car" and that he was offered a ride home by the driver.

Nicolas said he believed he may have seen the driver in Brooklyn's earlier. Nicolas said the vehicle was parked on S. 95 St. and originally thought it was a dark grey Toyota. I asked Nicolas if the vehicle was possibly a BMW and he

said agreed it was a dark colored BMW or Audi. Nicolas said he was in the vehicle with a male, identified by Police as Keith, for approximately 45 minutes. Nicolas believed Keith's name was Brian, however, he described the driver as mid 30's in age, 5'9, wearing a gray coat and clean shaven. Nicolas said he thought he was being driven home. Nicolas said he agreed to go to taco bell with Keith, and specified what food he ordered and the Keith purchased the food. Nicolas said Keith answered his cell phone while they were in the car. Nicolas said "it sounded like an interesting conversation." Nicolas elaborated by saying he though he heard "stabbing" in the conversation.

Nicolas said Keith stopped the car and exited while he was still talking on the phone. Nicolas said he walked away from the car because he thought Keith was leaving. Nicolas said he was later approached by Police Officers while he was attempting to walk home. I told Nicolas that I was informed by other Officers that he was in possession of several prescription medications. Nicolas said he had two separate bags of pills. Nicolas said one of the bags was his, which contained Percocet, Xanex, muscle relaxers, and heartburn medication. Nicolas said the second bag contained approximately 25 Oxycodone pills, which belonged to his ex-wife. Nicolas said he did not use the Oxycodone pills because they would interfere with his Percocet medication. Nicolas went on to say that I would understand if I needed to take pain medication as he does. Nicolas claimed his ex-wife told him to hold onto the pills for her. Additionally, Nicolas said he see his ex-wife approximately 2 times per week but maintains possession of a portion of her pills. Nicolas said he was then transported to the WAPD.

After Nicolas provided his initial statement he stated "I'm guessing my sequence of events are a lot different then yours." Nicolas also stated that he had a "rough day" due to being denied a job he recently applied for. I asked Nicolas to attempt to clarify his actions from leaving Brooklyn's and entering the BMW. Nicolas said he did not know. Nicolas stated several times he could not recall specifically what happened, said he may have "blacked out", or doesn't remember the walk because it was un-eventful. I asked Nicolas if he observed any disturbance, argument, or fight while he walked to the BMW and he said he did not remember. I informed Nicolas that several witnesses identified him as stumbling on the sidewalk, mumbling, and then accessing a knife and stabbing another male in the arm. Nicolas said he did not know how to respond. Nicolas said he believes me when I told him he was identified as the offender and does not refute my statement, except that he does not remember. Nicolas said "I have no recollection" several times.

Nicolas then compared this instance to his third offense OWI. Nicolas said he doesn't remember driving his car but remembers the arrest process and only being "angry." I informed Nicolas that he was able to provide specifics details about his actions directly prior to exiting Brooklyn's, as well as directly after getting in the car. I told Nicolas that his statement of

blacking out and not remembering does not make sense. I told Nicolas that he did not show any signs of remorse or emotion in regards to the incident and he replied "remorse will come." I asked Nicolas why he had the knife in his boot. Nicolas said he observed a Police car on the street and believed he should move the knife from his pocket to his boot. Nicolas did not have any other pertinent information in regards to the case.

I concluded the interview at 0856hrs. I later placed the digital media card in a secure envelope placed it in the Forensic/ Technical Services Bureau secure drawer.

#### CONSENT TO SEARCH

After speaking with Nicolas, I re-initiated contact with the Keith and asked him if I had consent to search the contents of his phone, as well as his BMW. Keith agreed and signed the voluntary consent form for his cell phone and BMW. I later handed these documents to Officer Molthen to place on property as evidence. I asked Keith if there was anything on his phone related to the incident. Keith said he talked about marijuana but said there was nothing else of concern on his phone.

#### CELL PHONE DATA

Keith provided me with the pin code for his Verizon Samsung phone. I located on text message that was sent to a "Cory" at 0236hrs that read "I need some bud can you help me." Additionally, Keith made 5 outgoing phone calls to Cory after 0230hrs, however, there was data or photographs that had any association to the incident at Brooklyn's. I later returned the phone to Keith.

## BOOKING

Based on the statements gathered on scene, and the statements of Keith and Nicolas, I did not arrest Keith in relation to the Brooklyn's incident. I booked Keith for identification purposes and he was later released.

## DISPATCH TO CALL/ARRIVAL ON SCENE

On 3/29/14 at 0224hrs officers responded to Brooklyn's, 9440 W National Ave, for a report of a stabbing. Officers arrived on scene and advised the suspect had left prior to officer arrival. I spoke with John Smith, who advised he witnessed the incident.

## STATEMENT OF WITNESS - JOHN SMITH

I spoke with John Smith, who advised he is best friends with the victim. Smith stated he was walking back to his vehicle with his friends when he turned and saw one of his friends running away from the car with a separate male walking behind him. Smith stated he did not know what was going on when he saw his friend holding his arm with what he believed to be blood running down it.

Smith stated he observed the male, approximately 5'11, 160 pounds with a mustache/goatee. Smith stated he never saw this male before and would not know why he would have wanted to stab his friend. Smith stated that he ran with his friends to W National Ave to get away from the male with the knife. Smith stated that male began to walk towards them but turned the other way and began running away.

Smith stated he observed the bouncers from the bar go and meet up with the male somewhere up the road, and the male came back with the bouncers near the front of their car. Smith went up to the male and stated "what the Fuck, you just stabbed my friend!" Smith stated the male had his hand behind his back and didn't know if he had the knife on his still. Smith stated the male brought the knife to the front where Smith observed it. Smith stated that the male didn't say anything but held the knife towards him and shook it.

Smith stated he moved back towards his friends again when the male began to walk towards him. Smith stated the male got into an older black sedan with someone else driving. Smith stated he observed the rear plate and had someone advise the police about it.

Smith stated he never saw his friend get stabbed but saw the individual on several occasions outside of the bar.

## INITIAL RESPONSE

On 03/30/14 at approx.  $0330 \, hrs$ , I was asked by Officer Molthen to administer a Photo Array to Brandon A. Feezor, M/W 10/28/83, a witness in this case. I responded to the WAPD lobby and made contact with Feezor, who I have had previous experience with and know to be employed as security at Brooklyns Gentlemen's Club. Prior to the Photo Array I was not involved in the investigation and had no knowledge of the incident.

## PHOTO ARRAY

I read the Witness Instructions for Sequential Photo Arrays to Feezor. I informed him that after I showed him every photograph I would ask, "Is this the person you saw involved in the stabbing at Brooklyns last night?" I began the Photo Array by showing Feezor the first photograph. When I got to the third photograph Feezor stated, "That's the guy." I asked him how sure he was. Feezor stated he was "90% sure." Feezor then signed the photograph and put "90% sure" next to his signature. Feezor added, "I would be shocked if it wasn't him."

I continued showing the remainder of the photographs to Feezor. He did not pick out any of the other subjects in the subsequent photographs. Feezor stated the man in photograph three looked, "A lot, lot like the guy." Feezor stated the offender from the night before looked like he had a "mini-stroke" and that the man in photograph three appeared to have the same look. Feezor stated the only way he could be "100% sure" was if the man in photograph three was wearing a baseball hat and the photograph was a full body picture.

# TURN OVER OF PHOTO ARRAY

I turned the Photo Array over to Officer Molthen. I informed Officer Molthen that Feezor signed photograph three. Officer Molthen looked at the photograph and informed me that the man pictured in photograph three was Nicholas R. Natarelli, M/W 04/23/74. Natarelli is the suspect in this case.
