This letter is in response to the Notice of Hearing for August 1, 2006. We have been notified of the request for a Special Use Permit, for Scotty's West Allis 6500 W Greenfield Avenue.

Please accept our letter as an opposition to the request.

We are the neighbor directly to the west of the tavern; we have experienced numerous negative situations when Scotty's was operating. For example:

- Illegal parked cars in our parking lot
- Broken beer bottle throughout our parking lot
- Vomit in our parking lot
- Urine in our flower beds
- Drug paraphernalia littered in our lot
- Cooking Oil and grease overflowing out of the oil container on to our parking lot
- Abandoned cars hanging over the parking garage apron
- Garbage overflowing the garbage container
- Overgrown weeds
- Overgrown lawn
- Unsightly boarded up windows, broken windows, paint tarps used as window treatments

We have a number of taverns and restaurants as neighbors of the Credit Union; these neighbors respect our property. When Scotty's is closed we do not experience any issues. Scotty's tavern is not the type of establishment that the City of West Allis has profiled for the Six Points Development Project.

We are also sending 20 pages of police incidents files obtained from the City Police Department. Note these are personal and Tavern related records.

Please do not consider issuing the permit.
