NOTICE IS HEREBY GIVEN that the Common Council of the City of Greenfield will hold a public hearing in the Common Council Chambers at the Greenfield City Hall, 7325 West Forest Home Avenue, Greenfield, Wisconsin, on <u>Tuesday, the 5th day of May, 2009 at 7:15 p.m.</u>, for the purpose of changing or adding to the Official Map of the City so as to establish the exterior lines of planned new streets, highways, historic districts, parkways, railroad rights-of-way, public transit facilities, waterways, parks or playgrounds or to widen, narrow, extend or close existing streets, highways, historic districts, parkways, railroad rights-of-way, public transit facilities, waterways, parks or playgrounds.

The proposed changes and additions to the Official Map to be considered at this hearing affect the following area:

The Northwest One-Quarter (1/4) of Section 17, Township Six (6) North, Range Twenty-one (21) East, City of Greenfield, Milwaukee County, Wisconsin, bounded on the north by West Oklahoma Avenue, on the east by South 100th Street, on the south by West Morgan Avenue, and on the west by South 108th Street.

The proposed change is as follows:

To amend the Official City Map so as to de-map a 15' x 375' area of potential future Morgan Avenue right-of-way in conjunction with the approved Schlossmann Honda City site and building redevelopment plan at 3450 S. 108th Street, Tax Key #524-8978-002 and 524-8979-004.

The hearing on the proposed changes and additions to the Official Map of the City of Greenfield adopted by Ordinance No. 493 is in compliance with Section 62.23(6)(b), Wisconsin Statutes, and the proposed changes and additions have been duly referred, considered and recommended by the Plan Commission of the City of Greenfield.
