Dear Mr. Droese:

On June 5, 2018 at approximately 2:50pm you were discovered sleeping near the south wall of the library. Staff attempted to wake you but it became clear that you were under the influence of alcohol and passed out. A police officer arrived and was able to wake you and escort you out of the building.

This incident on June 5th is yet another incident where your behavior violated the West Allis Public Library Code of Conduct. Other documented examples include:

- On March 19, 2018 at about 5:00pm you confronted a group of teenage boys inside the library.
 You were under the influence of alcohol and threatened to fight the boys who were not being disruptive.
- On April 27, 2018 you incited a fight in the men's restroom with another patron. Again, you were clearly intoxicated. Police were called and you were escorted out of the building.

The behavior you've exhibited is in violation of the West Allis Public Library Code of Conduct. <u>You are immediately banned from being present on Library property including the building, parking lot and outside seating areas.</u>

At its meeting on June 27, 2018 the West Allis Public Library Board of Trustees will vote to affirm this immediate ban. After that meeting you will receive a letter explaining your options for appeal and reinstatement.

If you ignore or violate this order, police will be called and you will be charged appropriately.

National Ave., for hours, refusing to leave, harassing customers and drinking from a bottle of vodka that police believe he stole from the grocery store, according to the police report.

Matthew Drose of West Allis was taken into custody about 6:20 p.m. Sunday, June 3. He was cited for retail theft, disorderly conduct, trespassing and resisting an officer.

Described by police as highly intoxicated, he resisted during booking and wound up with a cut on his head, so he was taken to the Aurora West Allis Medical Center. There he caused a disturbance by yelling obscenities. He was cited again for disorderly conduct.
