TO EACH OF THE ABOVE NAMED PARTIES:

Pursuant to the provisions of § 893.80, Wis. Stats., the Claimant, Robert Kuhn, hereby gives formal Notice of Claim and makes a claim for relief in the form of monetary damages, as set forth below.

1. That Robert Kuhn resides at 6700 W. Beloit Road in the City of West Allis and the County of Milwaukee, Wisconsin 53219.
2. That on or about October 10, 2017, Mr. Kuhn was riding his bike northbound on the sidewalk on the north side of Beloit Road in West Allis.
3. That on that date, Scott Portz, an on duty City of West Allis firefighter, drove up to the north bound stop sign at the intersection of 67th Place and Beloit. At the same time, Mr. Kuhn was on his bicycle, crossing the same intersection in the crosswalk, when Mr. Portz pulled into the intersection without coming to a complete stop, and struck Mr. Kuhn.
4. As a result of these circumstances, Mr. Kuhn suffered property damage to his bicycle, injuries to his neck and foot, among other injuries, and he has incurred medical costs.
