An Ordinance to Establish Parking Restrictions on the North Side of the West 120 Feet of the 7500 Block of W. Lincoln Avenue.

PART I. Pursuant to Section 10.10 of the Revised Municipal Code, the following parking restriction is established:

Street: W. Lincoln Ave.

Block: West 120 Feet of the 7500 Block

Side: North

Restriction: No Parking, No Stopping, No Waiting Anytime Except Buses

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
