Vacation and discontinuance of an improved alley between W. Electric Ave. and W. Mobile St. west of S. 54 St.

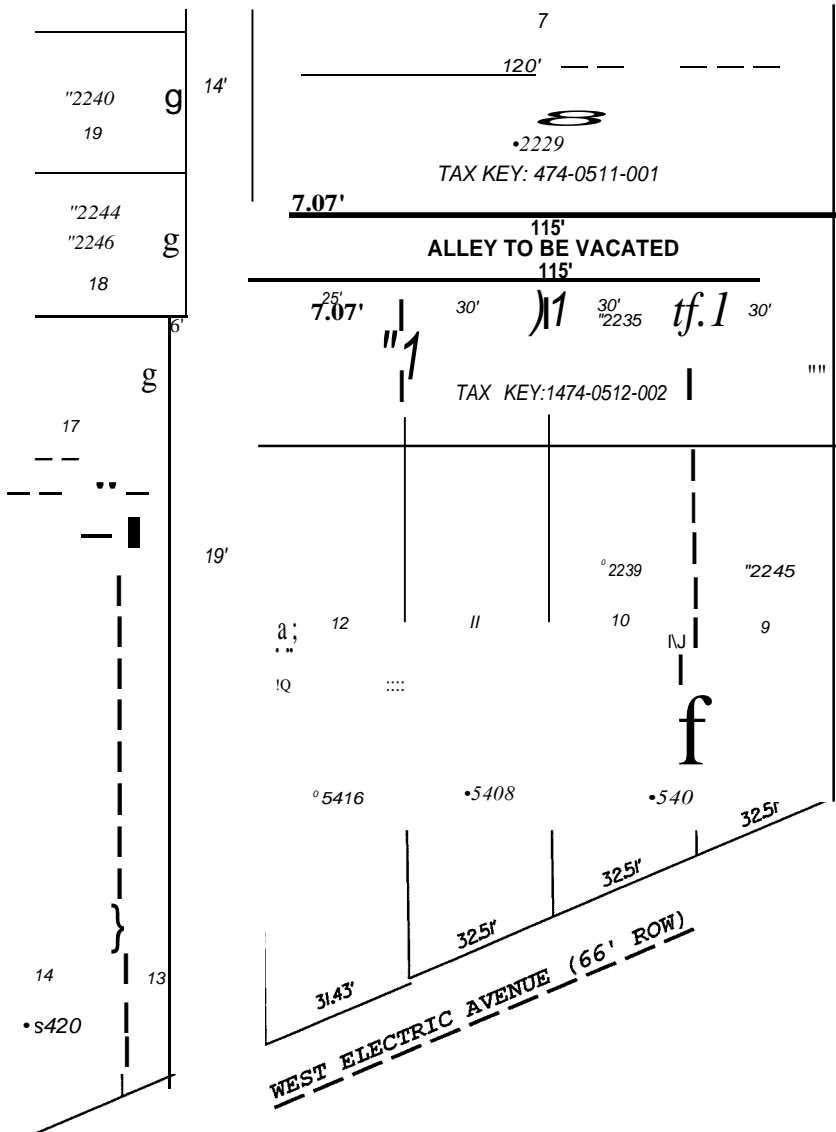

DESCRIPTION & LOCATION

Public alley located in the Southwest l/4 of Section 2, Township 6 North, Range 21 East, in the City of West Allis, Milwaukee County, State of Wisconsin, more particularly described as follows:

Beginning at the Southeast corner of Lot 8, in Block 9 of the McGeoch's Lincoln Avenue Addition subdivision: thence Southerly, 14.00 feet, along West right-of-way line of South 54th Street; thence Westerly, 115.00 feet; thence Southwesterly, 7.07 feet, to the East right-of-way line of public alley; thence Northerly, 24.00 feet; thence Southeasterly, 7.07 feet; thence Easterly, 115.00 feet, to the Point of Beginning.
