RE: City Attorney's Report of Claim

Dear Council Members:

The enclosed claim has been referred to this office in accordance with Section 3.05 (8) of the Revised Municipal Code. This office has examined the facts of the claim and the applicable law. Our Opinion regarding liability is as follows:

It is the recommendation of this office that the following claim be denied:

Sook Ja Kim - Amount: \$1,063.50

This is a claim for property damage to the claimant's vehicle on December 23rd, 2008, at the intersection of West Beloit Road and South Buchanan Place in the City of West Allis. At said time and place, the claimant's vehicle, while heading north on Buchanan Place collided with another vehicle heading westbound on Beloit Road while the claimant was attempting to make a left hand turn to proceed westbound on Beloit Road. Due to the accident, the claimant was issued a traffic citation by the City of West Allis Police Department for failure to yield the right-of-way at an uncontrolled intersection. Both vehicles involved in the accident incurred damages as a result of the collision, while it did not appear from the reports that either party suffered personal injuries. The claimant's claim, filed against the City on January 30th, 2009, states that the cause of the accident was the fault of the City for its failure to remove the snow piled up at the intersection thus blocking the claimant's vision making it impossible for her to safely cross the intersection or make a left hand turn onto West Beloit Road. The claimant is seeking the cost to repair her vehicle as a result of the accident.

Our investigation into this claim indicated that there is no basis for holding the City negligent in this case. While it is true that the snow was piled high at the intersection, this does not relieve motorists of having to proceed with caution while negotiating around said snow banks. All municipalities have to deal with the issue of piled up snow at intersections during the winter based on the amount of snowfall in any given year. Motorists simply need to exercise more patience and caution when traveling through snow blocked intersections in the winter. The City simply did not create a hazardous condition at the intersection that other motorist where unable to travel around. Rather, the piled up snow made the intersection more dangerous than normal requiring motorists to use additional caution and keep a proper look out at all times, which was not done by the claimant. Thus, the City is not legally liable for the damages to claimant's vehicle in this case.

Based upon the above, it is the recommendation of the City Attorney's Office to deny this claim pursuant to the provisions of Wisconsin Municipal Claims Statute 893.80.
