Assistant Director of Public Works - January 1, 2010-December 31, 2010

Beginning Bi-Weekly Rate (80%) - \$2,923.20

Ending Bi-Weekly Rate (100%) - \$3,653.60

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in full force from and after its passage and publication.


